The Advisory Council on the Misuse of Drugs (ACMD) is a statutory and nonexecutive non-departmental public body, established by the Misuse of Drugs Act (MDA) 1971. The ACMD has a statutory duty to keep under review the situation in the United Kingdom with respect to the misuse of drugs and to advise Ministers of the measures which they consider should to be taken to deal with social problems which arise from drug misuse. In addition, the ACMD has a duty to consider any matter relating to drug dependence or misuse that may be referred to them by Ministers. The Home Secretary is obliged by law to consult the ACMD before laying Orders or making regulations.

The aim of the Working Group is to estimate the current size of this population and make projections for future demographics and needs for this population over a 10 and 20 year period; to look at service needs beyond specialist treatment service to include physical and mental health and social care needs; and to formulate recommendations to improve policy and practice responses for this group of users.

The Working Group members will consider both oral and written evidence from key stakeholders.
