Thank you for your email of 10 October 2016 requesting an internal review of the decision taken in this case by our Information Officer, Asim Hussain. I have now had an opportunity to review the case, and I can find no fault in the way your original request was handled or the decision that was reached.

However, in response to your subsequent request – which clarified that you were interested in learning what meetings had taken place and not simply receiving the associated minutes – I am more than happy to provide you with such information as we hold. I apologise for the delay in replying, but it has taken some time to gather the details you require.

The attached document provide a comprehensive list of direct meetings between the OISC and the LSB and between the OISC and the SRA held during 2015 and 2016. The document also includes a table showing meetings hosted by third parties which were attended by representatives from the OISC and the LSB or SRA. In these cases we have done our best to identify which individuals attended the meetings, but our records do not always provide a definitive record of precisely who attended – some of the meetings being large events with numerous delegates.

For the sake of completeness I should add that at certain meetings hosted by third parties involving the exchange of information between law enforcement authorities, OISC representatives have taken notes which have subsequently been circulated to colleagues within this Office. However, I must clarify that these are not formal minutes, and we are in any case unable to share them with you because they constitute information held by us for the purposes of investigating whether an individual should be charged with a criminal offence – rendering them exempt from disclosure.
