Top Tips

◆ **Ensure you use the correct portal**

If the Sponsor sends the activation email to your RLI account you must complete the form at work. If it comes to your home emails address i.e. hotmail. you must complete the form on your home PC. You cannot switch between the two.

◆ **Who to contact for assistance**

Your Sponsor is the only one with access to your details to set up your account. You must contact them if you cannot access your form or you get locked out.

Contact **DBS-NSV** for help with completing the form. See contact details below.

◆ **Forgotten Password**

Select the 'Forgotten your username?' link. This will take you to a 'Recover Username' screen. Here you will be asked to enter 3 pieces of information to identify you as the valid applicant. The email address required is the same address that the activation email was sent to and must be entered in lower case only

If your application is locked you **MUST** contact your SPONSOR with a request to unlock it.

What information will I need to complete the form?

It is advisable to gather as much information as possible before starting to complete the form, **you will require:**

- ◆ **Your full Details (including ALL middle names)**
- ◆ **Parents and their Partners full details**
- ◆ **Partners Parents full details (for DV only)**
- ◆ **ALL Siblings (if they are over 18)**
- ◆ **Your financial information**
- ◆ **Employment information for the last 5 years (10 yrs for DV)**
- ◆ **Supervisor information for the last 5 years (10 yrs for DV)**
- ◆ **Details of any Criminal Convictions (Spent and Unspent)**
- ◆ **ALL Previous addresses for last 5 years (10 years for DV) including university/military and temporary accommodation.**
- ◆ **Details of any co-residence including all Children over 18 even if they are at University and return home regularly (for DV only).**
