I am writing in response to your request for information regarding the below received on 12 February 2015. Your request has been handled under Section 1(1) of the Freedom of Information Act 2000. In accordance with Section 1(1)(a) of the Act I hereby confirm that the CNC/CNPA does not hold information of the type specified.

On 6th October 2014, the Rt Hon. Sir Paul Kennedy, Interception of Communications Commissioner, stated:

Today I have written to all Chief Constables and directed them under Section 58(1) of RIPA to provide me with full details of all investigations that have used Part I Chapter 2 RIPA powers to acquire communications data to identify journalistic sources.

Please provide the following:

- 1. A copy of all the information provided by your police force to the IOCCO in response to the Interception of Communications Commissioner's request.**

The CNC was not asked for information by IOCCO for this inquiry and hence there is no correspondence or any forms in relation to it. The CNC has been subject to recent inspections by IOCCO where, due to the very low range of activity undertaken by CNC in relation to acquiring communications data, all applications for data and the investigations to which they related were scrutinised. Consequently, IOCCO were aware already that none of the activity in which CNC had engaged was of relevance to their enquiry. The CNC has never engaged in any investigation which has involved journalistic sources. The CNC is one of several public bodies which have recently been removed from the Schedule of organisations with the power to acquire communications data due to the historically low use of the powers granted under RIPA

The Civil Nuclear Constabulary is a specialist armed police service dedicated to the civil nuclear industry, with Operational Policing Units based at 11 civil nuclear sites in England, Scotland and Wales and over 1400 police officers and staff. The Constabulary headquarters is at Culham in Oxfordshire. The civil nuclear industry forms part of the UK's critical national infrastructure and the role of the Constabulary contribute to the overall framework of national security.

The purpose of the Constabulary is to protect licensed civil nuclear sites and to safeguard nuclear material in transit. The Constabulary works in partnership with the appropriate Home Office Police Force or Police Scotland at each site. Policing services required at each site are agreed with nuclear operators in accordance with the Nuclear Industries Security Regulations 2003 and ratified by the

UK regulator, the Office for Nuclear Regulation (ONR). Armed policing services are required at most civil nuclear sites in the United Kingdom. The majority of officers in the Constabulary are Authorised Firearms Officers.

The Constabulary is recognised by the Association of Chief Police Officers of England, Wales and Northern Ireland (ACPO) and the Association of Chief Police Officers in Scotland (ACPOS). Through the National Coordinated Policing Protocol, the Constabulary has established memorandums of understanding with the local police forces at all 11 Operational Policing Units. Mutual support and assistance enable the Constabulary to maintain focus on its core role.

We take our responsibilities under the Freedom of Information Act seriously but, if you feel your request has not been properly handled or you are otherwise dissatisfied with the outcome of your request, you have the right to complain. We will investigate the matter and endeavour to reply within 3 – 6 weeks. You should write in the first instance to:
