THE CORNWALL COUNCIL (BRIDLEWAY No.11, LANEAST (PART)) (COOMBEGATE, PIPERS POOL) PUBLIC PATH DIVERSION ORDER 2015

THIS ORDER is made by Cornwall Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted;

Mr R Tate has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER:

- 1. The public right of way over the land situate at "Coombegate" in the Parish of Laneast shown by a bold continuous line on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which Cornwall Council certify that work has been carried out to bring the site of the new highway mentioned in Part 2 of the Schedule to this Order into a fit condition for use by the public.
- 2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the same rights over the land referred to in paragraph 1 above, in respect of their apparatus under, in, upon, over, along, or across the said land as they had immediately before the date of confirmation of this Order.
- 3. There shall at the end of 28 days from the date of confirmation of this Order be a public bridleway over the land situate west of "Coombegate" in the Parish of Laneast described in Part 2 of the Schedule to this Order and shown by a bold broken line with cross bars on the map attached to this order.

The rights conferred on the public by this Order shall not be subject to any Limitation or Condition.

This Order may be cited as "The Cornwall Council (Bridleway No.11, Laneast (Part)) (Coombegate, Pipers Pool) Public Path Diversion Order 2015".



SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A length of Public Bridleway number 11 in the Parish of Laneast commencing from a point where it has a junction with that part of Bridleway number 11 Laneast to be retained approximately 360 metres north-west of the property "Coombegate" at Ordnance Survey Grid Reference (OSGR) SX 2454/8472 shown as Point "A" on the attached map thence running in a generally south-easterly and then southerly direction for a distance of 504 metres to a point where it has a junction with the northern margin of County Road A395 approximately 125 metres south of the property "Coombegate" at OSGR SX 2484/8433 shown as Point "B" on the attached map.

The Definitive Statement records an average width for Bridleway number 11 Laneast of 6'0" (six feet). For the avoidance of doubt it is intended to stop up the highway described above in its entirety.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A length of Public Bridleway in the Parish of Laneast commencing from a point where it has a junction with that part of Bridleway number 11 Laneast to be retained approximately 360 metres north-west of the property "Coombegate" at Ordnance Survey Grid Reference (OSGR) SX 2454/8472 shown as Point "A" on the attached map thence running in a generally south-westerly then southerly then south-easterly then south-south-easterly then south-westerly direction for a distance of 350 metres to a point where it has a junction with the northern margin of County Road A395 approximately 360 metres west of the property "Coombegate" at OSGR SX 2445/8445 shown as Point "C" on the attached map.

The Public Bridleway described above shall have a width of 3.0 (three) metres throughout.


