UPDATES TO PLANS FOR HIGH SPEED TWO: SUPPLEMENTARY ENVIRONMENTAL STATEMENT 3 AND ADDITIONAL PROVISION 4

In November 2013 the Government deposited a Bill in Parliament to provide powers to construct, operate and maintain the first phase of the High Speed Two (HS2) railway, between London and the West Midlands. Alongside it was an Environmental Statement (ES) setting out the likely significant effects of the proposals.

The Government is now depositing a further set of documents – a Supplementary Environmental Statement (SES) and an Additional Provision (AP) – as part of its proposed changes to the Bill.

Why are the proposals being changed?

The proposed changes reflect:

- our discussions with landowners, occupiers and stakeholders;
- · our refinements to the design; and
- updated environmental information (including environmental surveys).

This SES is the third one we have deposited and so is called 'SES3'. It reports on the likely significant environmental effects of:

- updated environmental information; and
- changes that are new, but are within the powers already being sought under the Bill, and within the limits described in it.

AP4 is the fourth additional provision to be deposited. It contains proposed changes which go beyond the existing powers and limits described in the Bill. AP4 comprises the following documents:

- a paper of amendments to the Bill;
- plans and sections that show the proposed changes;
- a book of reference, identifying the owners and occupiers of affected land; and
- the AP Environmental Statement (AP4 ES), which reports on the significant environmental effects that the AP changes are likely to have, and outlines the measures that are being proposed to avoid, reduce or manage these effects.

The SES3 and AP4 ES are separate environmental statements, but are presented in combined volumes so that they can be reviewed together.

Can I comment on SES3 and the AP4 ES?

Yes. The Government is consulting on SES3 and the AP4 ES. The consultation will run until 11:59 on 27 November 2015.

What is an AP?

An Additional Provision is a package of proposed amendments to a Bill.

APs are part of normal procedure for projects of this kind; a number of APs may be put forward on the Bill's journey through Parliament.

This is the fourth AP on this scheme; the first was deposited in September 2014, the second in July 2015 and the third in September 2015.

What are "existing powers and limits"?

The 'existing powers' are the powers to build and operate the railway and associated works, as sought in the original Bill. The 'existing limits' are the land they cover.

AP4 proposes changes to the Bill that are outside this original scope (eg, where land would now be needed permanently, rather than used temporarily).

Can I object to SES3 and AP4?

Anyone directly affected by the proposals in SES3 and AP4 may submit petitions against them in the House of Commons. The last date for depositing a petition against the proposals is 13 November 2015.

Where are the documents available?

How do I find the environmental information I need?

SES3 and the AP4 ES are composed of a number of documents: all of them are publicly available.

Non-technical summary

This is a summary of the changes and any likely significant residual effects on the environment. You may find this a useful place to start.

Volume 1: Introduction and methodology

This introduces:

- the supplementary environmental information and design changes in SES3; and
- the amendments that have resulted in the need to amend the Bill in the AP4 ES.

It also explains any changes to the basis of the environmental impact assessment - its scope, method, assumptions and limitations.

Volume 2: Community forum area (CFA) report and map book

Each of these reports focuses on a particular area along the route. Volume 2 describes:

- the supplementary environmental information and design changes included within the SES3 (Part 1); and
- amendments within the AP4 ES (Part 2).

Volume 2 reports any significant environmental effects that are likely to arise, if the effects are new or different from those reported in previous ESs.

It also sets out the measures that are being proposed to avoid, reduce or manage the effects.

Each CFA report is supported by a map book showing 'before' and 'after' details of the proposed changes and amendments.

Volume 3: Route-wide effects

This volume reports any likely significant route-wide effects, where these are new or different from those previously reported.

Volume 4: Off-route effects

This volume reports any new or different significant effects that are likely to arise, where these changes affect areas away from the HS2 route.

Volume 5: Technical appendices and map books

This volume comprises technical appendices which contain supporting environmental surveys, information and maps.
