Notice is hereby given that the above referenced Orders have been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Orders.

The **start date** for the above Orders is 14 October 2015.

Consideration of the Orders will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Orders, if confirmed without modifications, will be to:-

- 1. Extinguish the public footpath crossing No 5 Forest Close enclosing the points marked Point A (Grid Reference 435869 348307) in an east south easterly direction for a distance of approximately 20 metres or thereabouts to Point B (Grid Reference 435888 348303) as shown on the associated order map.
- 2. Extinguish the public footpath enclosing the points marked Point A (Grid Reference 435923 348290) in a east, south easterly direction for a distance of approximately 36.6 metres or thereabouts to Point B (Grid Reference 435959 348297) as shown on the associated order map.
- 3. Extinguish the public footpath enclosing the points marked Point A (Grid Reference 435959 348297) in an east, south easterly direction for a distance of approximately 127.95 metres or thereabouts to Point B (Grid Reference 436078 348250) as shown on the associated order map.

#### Within 2 weeks of the start date [by 28 October 2015]

As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

#### Within 8 weeks of the start date [by 09 December 2015]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

### Within 14 weeks of the start date [by 20 January 2015]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the timetable</u> to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
