

# **NOTICE OF ORDER**

## **WILDLIFE AND COUNTRYSIDE ACT 1981**

### **SECTION 53**

Bath & North East Somerset Council  
(City of Bath Definitive Map and Statement Modification Order) Footpaths  
BC54/40 and BC64/1 (No. 11 - Bathwick & Combe Down) 2015

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 13 July 2016.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by adding to them the following footpaths:

1. A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7586 6465 on Sydney Buildings and continuing up steps for a distance of approximately 36 metres in a generally east-north-easterly direction to point B at Grid Reference ST 7589 6466 where it is joined by public footpath BC54/39. The footpath continues for a distance of approximately 8 metres to where the direction changes to generally easterly at point C at Grid Reference ST 7590 6466. The footpath continues for a distance of approximately 8 metres to point D at Grid Reference ST 7591 6466 where the steps end. The footpath continues for a distance of approximately 107 metres to point E at Grid Reference ST 7601 6466 where the direction changes to generally south-easterly at its junction with public footpath BC64/2. The footpath continues for a distance of approximately 357 metres to point F at Grid Reference ST 7632 6448 where the direction changes to generally south-westerly at the junction with public footpath BC64/6. The footpath continues for a distance of approximately 4 metres to a gate at point G at Grid Reference ST 7632 6447. The footpath continues for a distance of approximately 189 metres to point H at Grid Reference ST 7622 6431 where the direction changes to generally southerly. The footpath continues for a distance of approximately 8 metres to point I at Grid Reference ST 7622 6430 where steps start. The footpath continues for a distance of approximately 51 metres to where the steps end at a gate at point J at Grid Reference ST 7620 6426. The footpath continues for a distance of approximately 93 metres, through point K at Grid Reference ST 7620 6424 to where it finishes on footpath CQ42 at point L at Grid Reference ST 7621 6417 and shown by a broken black line with short intervals marked A-B-C-D-E-F-G-H-I-J-K-L on the map numbered Part 2 annexed to the order, the number of this footpath to be known as BC54/40.

2. A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7648 6488 on public footpath AQ36 and continuing for a distance of approximately 53 metres in a generally north-easterly direction to a kissing gate at point B at Grid Reference ST 7653 6490 where the direction changes to generally easterly. The footpath continues for a distance of approximately 2 metres to where it meets Golf Course Road at point C at Grid Reference ST 7653 6491. The footpath continues for a distance of approximately 4 metres across the Golf Course Road to point D at Grid Reference ST 7653 6491. The footpath continues for a distance of approximately 42 metres to point E at Grid Reference ST 7658 6490 where the direction changes to generally southerly. The footpath continues for a distance of approximately 17 metres to point F at Grid Reference ST 7657 6489 where the direction changes to generally south-easterly. The footpath continues for a distance of approximately 8 metres to point G at Grid Reference ST 7658 6488 where the direction changes to generally southerly. The footpath continues for a distance of approximately 6 metres to point H at Grid Reference ST 7658 6488 where the direction changes to generally south-easterly. The footpath continues for a distance of approximately 19 metres to point I at Grid Reference ST 7659 6486 where it finishes on public footpath BA1/20 at Grid Reference ST 7659 6486 and shown by a broken black line with short intervals marked A-B-C-D-E-F-G-H-I on the map numbered Part 4 annexed to the order, the number of this footpath to be known as BC64/1.

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

**Within 14 weeks of the start date [by 19 October 2016]**

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

**In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.**

This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, that rights of way which are not shown in the map and statement subsist or are reasonably alleged to subsist over land in the area to which the map relates, being rights of way such that the land over which the rights subsist are public paths or bridleways.

The authority has consulted with every local authority whose area includes the land to which the order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this order the relevant date is 14<sup>th</sup> April 2015.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No. 11 - Bathwick and Combe Down) 2015.

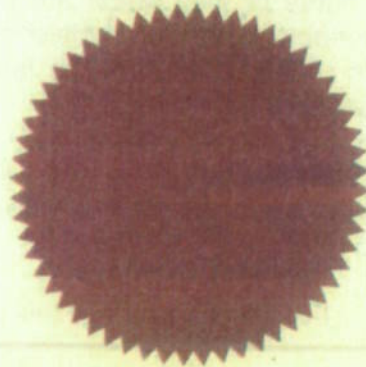

The footpath continues for a distance of approximately 107 metres to point E at Grid Reference ST 7601 6466 where the direction changes to generally south-easterly at its junction with public footpath BC64/2. The footpath continues for a distance of approximately 357 metres to point F at Grid Reference ST 7632 6448 where the direction changes to generally south-westerly at the junction with public footpath BC64/6. The footpath continues for a distance of approximately 4 metres to a gate at point G at Grid Reference ST 7632 6447. The footpath continues for a distance of approximately 189 metres to point H at Grid Reference ST 7622 6431 where the direction changes to generally southerly. The footpath continues for a distance of approximately 8 metres to point I at Grid Reference ST 7622 6430 where steps start. The footpath continues for a distance of approximately 51 metres to where the steps end at a gate at point J at Grid Reference ST 7620 6426. The footpath continues for a distance of approximately 93 metres, through point K at Grid Reference ST 7620 6424 to where it finishes on footpath CQ42 at point L at Grid Reference ST 7621 6417 and shown by a broken black line with short intervals marked A-B-C-D-E-F-G-H-I-J-K-L on the map numbered Part 2 annexed to this order, the number of this footpath to be known as BC54/40.

#### **BC63/2**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7678 6377 on restricted byway BC62/1 and continuing for a distance of approximately 431 metres in a generally south-easterly direction to a stone stile at point B at Grid Reference ST 7720 6370. The footpath continues for a distance of approximately 17 metres to point C at Grid Reference ST 7722 6369 where it finishes on public footpath BC73/2 and shown by a broken black line with short intervals marked A-B-C on the map numbered Part 3 annexed to this order, the number of this footpath to be known as BC63/2.

#### **BC64/1**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7648 6488 on public footpath AQ36 and continuing for a distance of approximately 53 metres in a generally north-easterly direction to a kissing gate at point B at Grid Reference ST 7653 6490 where the direction changes to generally easterly. The footpath continues for a distance of approximately 2 metres to where it meets Golf Course Road at point C at Grid Reference ST 7653 6491. The footpath continues for a distance of approximately 4 metres across the Golf Course Road to point D at Grid Reference ST 7653 6491. The footpath continues for a distance of approximately 42 metres to point E at Grid Reference ST 7658 6490 where the direction changes to generally southerly. The footpath continues for a distance of approximately 17 metres to point F at Grid Reference ST 7657 6489 where the direction changes to generally south-easterly. The footpath continues for a distance of approximately 8 metres to point G at Grid Reference ST 7658 6488 where the direction changes to generally southerly. The footpath continues for a distance of approximately 6 metres to point H at Grid Reference ST 7658 6488 where the direction changes to generally south-easterly. The footpath continues for a distance of approximately 19 metres to point I at Grid Reference ST 7659 6486 where it finishes on public footpath BA1/20 at Grid Reference ST 7659 6486 and shown by a broken black line with short intervals marked A-B-C-D-E-F-G-H-I on the map numbered Part 4 annexed to this order, the number of this footpath to be known as BC64/1.

#### **BC64/2**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7601 6466 on public footpath BC54/40 and continuing in a generally north-easterly direction for a distance of approximately 43 metres to where it finishes at point B on Bathwick Hill at Grid Reference ST 7604 6469 and shown by a broken black line with short intervals marked A-B on the map numbered Part 5 annexed to this order, the number of this footpath to be known as BC64/2.

#### **BC64/3**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7657 6466 on public footpath BA1/20 and continuing for a distance of approximately 264 metres in a generally south-easterly direction to where it finishes on North Road at point B at Grid Reference ST 7671 6444 and shown by a broken black line with short intervals marked A-B on the map numbered Part 6 annexed to this order, the number of this footpath to be known as BC64/3.

**BC64/4**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7677 6447 on public bridleway BC74/4 and continuing for a distance of approximately 31 metres in a generally north-westerly direction to point B at Grid Reference ST 7675 6449 where steps start. The footpath continues up the steps for a distance of approximately 19 metres to where the steps end at point C at Grid Reference ST 7675 6451. The footpath continues for a distance of approximately 34 metres to point D at Grid Reference ST 7675 6455 where the direction changes to generally north-easterly. The footpath continues for a distance of approximately 22 metres to point E at Grid Reference ST 7677 6456 where it is joined by public footpaths BA1/38, BA1/39 and BC64/5. The footpath continues for a distance of approximately 172 metres to where it finishes on public bridleway BC74/4 at point F at Grid Reference ST 7689 6468 and shown by a broken black line with short intervals marked A-B-C-D-E-F on the map numbered Part 7 annexed to this order, the number of this footpath to be known as BC64/4.

**BC64/5**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7677 6456 on public footpaths BC64/4, BA1/38 and BA1/39 and continuing for a distance of approximately 4 metres in a generally south-easterly direction to point B at Grid Reference ST 7677 6456 where a footbridge starts. The footpath continues along the footbridge for a distance of approximately 22 metres to where it ends at point C at Grid Reference ST 7679 6455. The footpath continues for a distance of approximately 374 metres to point D at Grid Reference ST 7707 6430 where the direction changes to generally south-south-easterly. The footpath continues for a distance of approximately 17 metres to point E where it finishes on Soldier Down Lane at Grid Reference ST 7707 6429 and shown by a broken black line with short intervals marked A-B-C-D-E on the map numbered Part 8 annexed to this order, the number of this footpath to be known as BC64/5.

**BC64/6**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7632 6448 on public footpath BC54/40 and continuing in a generally northerly direction for a distance of approximately 35 metres to where it finishes at point B on Bathwick Hill at Grid Reference ST 7633 6451 and shown by a broken black line with short intervals marked A-B on the map numbered Part 9 annexed to this order, the number of this footpath to be known as BC64/6.

**BC65/5**

A footpath in Bath and North East Somerset running from steps at point A at Grid Reference ST 7642 6574 on Warminster Road and continuing in a generally south-easterly direction for a distance of approximately 3 metres to where the steps end at point B at Grid Reference ST 7643 6574. The footpath continues for a distance of approximately 24 metres to where it finishes on Minster Way at point C at Grid Reference ST 7644 6572 and shown by a broken black line with short intervals marked A-B-C on the map numbered Part 10 annexed to this order, the number of this footpath to be known as BC65/5.



#### **BC65/6**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7608 6549 on Warminster Road and continuing for a distance of approximately 20 metres in a generally south-south-easterly direction to point B at Grid Reference ST 7609 6547 where the direction changes to generally east-south-easterly. The footpath continues for a distance of approximately 23 metres to where it finishes on St Christopher's Close at point C at Grid Reference ST 7612 6547 and shown by a broken black line with short intervals marked A-B-C on the map numbered Part 11 annexed to this order, the number of this footpath to be known as BC65/6.

#### **BC65/7**

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7624 6504 on Cleveland Walk and continuing for a distance of approximately 118 metres in a generally east-south-easterly direction to steps at point B at Grid Reference ST 7636 6502. The footpath continues for a distance of approximately 4 metres to a kissing gate at point D at Grid Reference ST 7789 6281 where the direction changes to generally south-easterly. 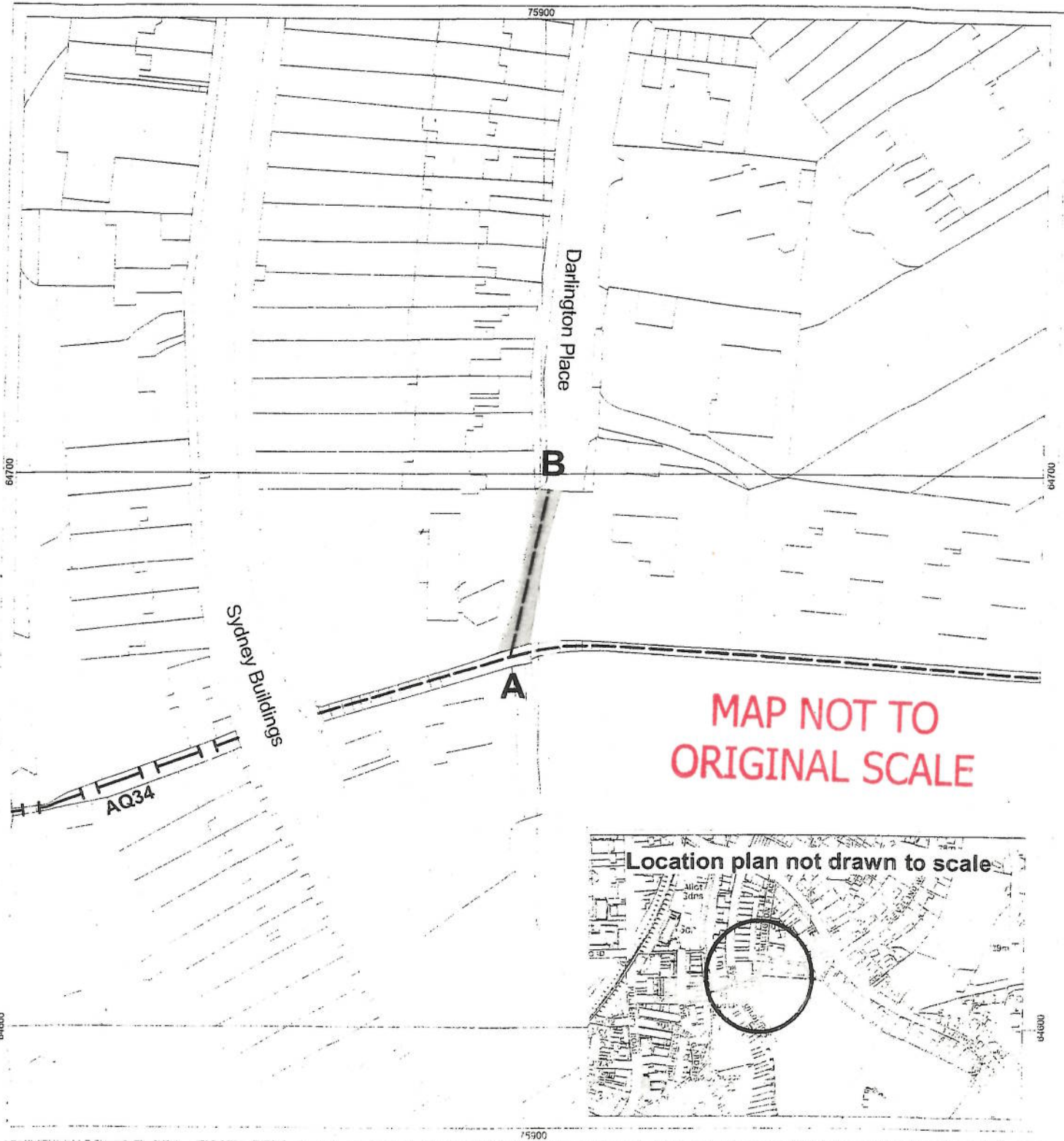

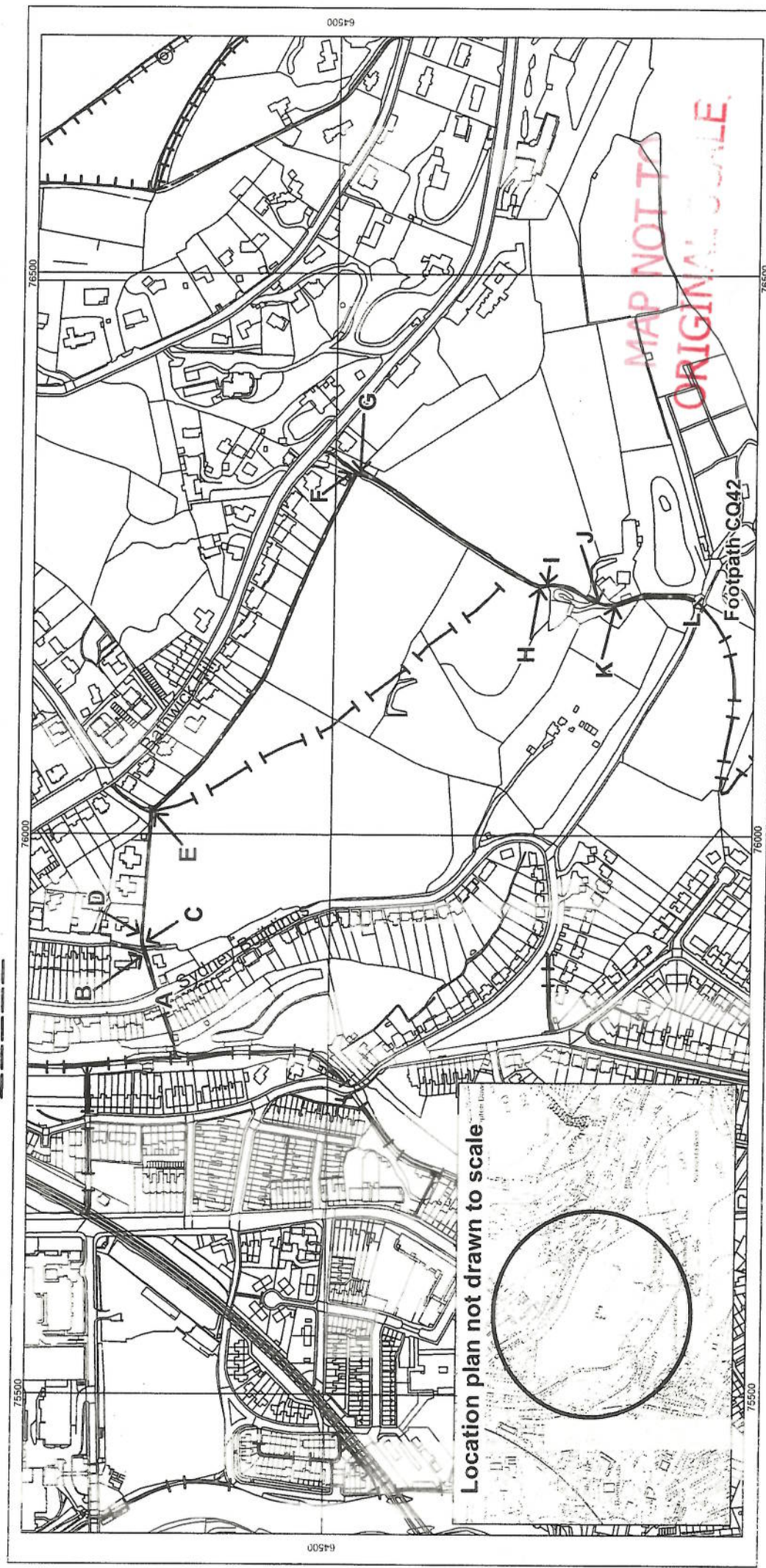

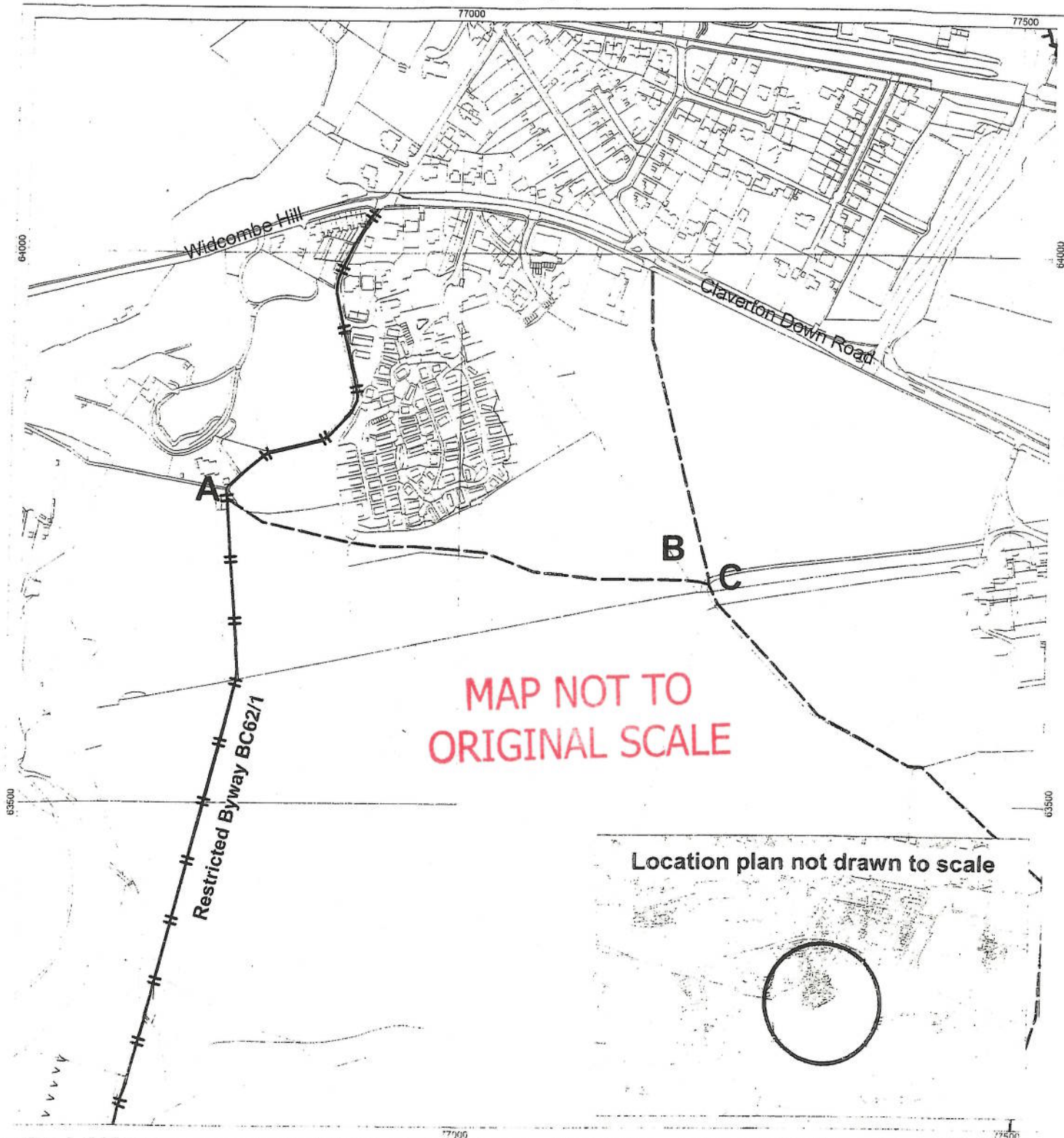
