### Health matters: improving the prevention and diagnosis of bowel cancer

PHE has launched the sixth edition of Health Matters, a resource for policy makers and practitioners, which brings together the facts, figures and evidence of effective interventions to tackle major public health problems. # PHE and the National Travel Health Network and Centre outline health and travel advice for the Olympics

PHE and NaTHNaC have published their advice for travellers planning to visit Brazil for the 2016 Olympic Games (5 August to 21 August) and the 2016 Paralympic Games (7 September to 18 September). The advice for the 2016 Olympics covers a variety of health and safety topics for travellers, including information about the Zika virus outbreak in Brazil. PHE and NaTHNaC currently recommend that pregnant women postpone non-essential travel to areas where there is active Zika virus transmission, until after pregnancy. On 13 and 14 June the new PHE NCRAS held the annual Cancer Data and Outcomes Conference for 2016. Hundreds of delegates from across the sector,

including many cancer patients, had the opportunity to hear leading experts discuss how cancer data is improving cancer prevention, early detection, treatment outcomes, patient experience, survivorship and end of life care with sessions on early diagnosis, health economics, therapeutic interventions, cancer in young and old people and inequalities. ### PHE response to the British Journal of Sports Medicine on Eatwell Guide

PHE responded to an editorial in the British Journal of Sports Medicine on the Eatwell Guide. UK dietary recommendations are based on scientific evidence reviews by independent experts. The reports are subject to public consultation, go through robust quality assurance processes and ensure there is no bias. The recent Scientific Advisory Committee on Nutrition's carbohydrates and health report included over 600 peer reviewed scientific papers. For more information, read the PHE news story.

#### Annual Flu Plan and Letter 2016/17

Last week PHE, with the Department of Health and NHS England, published the Annual Flu Plan and Letter 2016/17. The letter provides information about the annual flu immunisation programme for 2016/17. The only change this year is the addition of the offer of the live attenuated influenza vaccine to children of appropriate age for school year 3. The Flu Plan for winter 2016/17 sets out a coordinated and evidence-based approach to planning for and responding to the demands of flu across England. For more information, visit the PHE website.

#### **Commissioning for Value: new focus packs**

NHS RightCare has now produced a further four Commissioning for Value packs. The new packs on cancer and tumours; mental health and dementia; maternity and early years; and musculoskeletal conditions and trauma now sit alongside the first three packs on cardiovascular disease, respiratory and neurological conditions. The packs have been produced for every CCG in England and support commissioners to identify the best opportunities for improving value for their populations. ### NHS Innovation Accelerator launched for a second year

Last year UCL Partners launched the NHS Innovation Accelerator (NIA) working in partnership with NHS England and the Academic Health Science Networks. The aim of the NIA is to support healthcare pioneers speed up their high-impact, low-cost innovations across the NHS to improve lives. On 17 June NHS England launched the NIA 2016, which is now open for applications from innovators both in the UK and overseas. The closing date is 1 August, with successful applicants to be announced in October. This year the programme focuses on three challenges based on population health needs: prevention, early intervention and long-term condition management.
