ARMED FORCES ALLOWANCES - DISPENSATIONS

1. Thank you for your recent letter regarding dispensations. As you rightly say, the recent implementation of JPA means that there is the need to seek your agreement to a revised set of dispensations in respect of the Service allowances administered by SP Pol Allowances.
2. Please find at Annex A a list of the allowances for which we seek dispensation. Full details of the nature and tax status of each allowance are contained in the MoD Joint Services Publication (JSP) 752 "Tri-Service Regulations for Allowances" along with the applicable rates (at Chapter 1, Section 6). For ease of reference the table at annex A identifies the relevant section of JSP752, the relevant section of ITEPA 2003 (where applicable) and any relevant additional comments regarding specific allowances. Please also find at Annex B a table of Tax Treatment of Service Allowances which aims to identify the relevant section of ITEPA 2003 covering each of our allowances. I have enclosed a copy of JSP752 on CD for your records and, if it is agreeable to you, I propose that we forward a revised version as and when substantive revisions occur. The rates of Allowance are published within the JSP at Chapter 1, Section 6 and I propose to forward to HMRC a revised version of that section each time the rates change. The rates applicable from 1 August 2006 have recently been issued but as they do not take effect until 1 Aug 06 are not yet in the JSP. Accordingly I enclose a revised copy Chapter 1, Section 6 with this letter. For completeness I have also enclosed a copy of the most recent Treasury certification under ITEPA 2003, Section 297(1) in relation to food allowances.
3. We agreed that you would pass this to [REDACTED] and that [REDACTED] would meet with us, in due course, to confirm that our understanding of why an allowance is non taxable is correct. In this respect we would welcome any changes that we need to make to Annex B. We would clearly provide any further information that may be needed. D/SP Pol



When we meet with [REDACTED] we would like to agree when we should update our dispensations e.g. when we change terms and conditions, rates of allowance for which there is a monetary limit, when relevant elements of tax law change etc. We also agreed that, ideally, the dispensations would exclude reference to specific rates unless this is essential e.g. in the case of motor mileage allowance.

4. We would like to take this opportunity to thank you for all your assistance in the past and we look forward to working with your successor.

Notes on LA Rates

- (a) **Rate A** Applies to personnel who, if required to live in Service single accommodation, would be exempt both food and accommodation charges.
- (b) **Rate B** Applies to personnel who, if required to live in Service single accommodation, would pay either single or UnAcc rate of food charge, but be exempt accommodation charges.
- (c) **Rate C** Applies to personnel who, if required to live in Service single accommodation, would pay either single or UnAcc rate of food charge, and accommodation charges.
- (d) **Rate D** Applies to single personnel who on posting to a new duty station where Service single accommodation is not available, occupy their privately owned accommodation, provided that all other conditions of entitlement to LA are met.
- (e) **Rate E** Applies to UnAcc personnel who on posting to a new duty station where Service single accommodation is not available occupy accommodation owned wholly or in part by the claimant, or his/her spouse, or dependant child, or by a non-public company in which any of the former maintain a financial interest - provided that the accommodation is not the claimant's main or family residence.
- (f) Claimants under 18 years of age and who receive New Entrant Rate of Pay are not required to pay council tax, therefore, when required to pay accommodation charges they will not pay the MOD's CILOCT. As appropriate LA rates include an element for MOD's CILOCT, 8p should be added to those rates marked with a (f). Claimants under 18 years of age who pay reduced accommodation charges, therefore, when required to pay accommodation charges, should have 39p (31p accommodation charges +8p CILOCT) added to those rates marked with a (f).
- (g) For single Northern Ireland Claimants add £3.55 until 31 March 2006.
- (h) For UnAcc Northern Ireland Claimants add £2.60 until 31 March 2006.
- (i) For single Northern Ireland Claimants add £3.66 until 31 March 2007.
