The following notice gives notice of the variation of an environmental permit.

The Industrial Emissions Directive (IED) was transposed in England on 27 February 2013 by the Environmental Permitting (England and Wales)(Amendment) Regulations (EPR) 2013. This variation implements changes brought about by the IED into this permit.

This facility treats non-hazardous waste with a capacity exceeding 75 tonnes per day involving biological treatment. The facility needs now to be permitted as an installation. This variation changes the 8th March 2008 Standard Rules permit 2008No16 to Standard Rules 2012No8 composting in open systems.




