OCCUPATIONAL THERAPIST

BACKGROUND INFORMATION

Occupational Therapists enable people of all ages who have physical, mental, social or multiple problems to cope with and adapt to any aspect of their life with more confidence and ability. Occupational Therapists deal with a wide range of people and treatment programmes vary greatly according to individual needs. They help people improve their life through participation in an occupation.

Occupational Health is split into two areas; the Health and Social Care sector and the non-statutory sector. The Health and Social Care sector is provided by law through the National Health Service and is available to everyone. The non-statutory sector covers areas like private health care, charitable organisations and independent Occupational Therapists (who are often self-employed).

INDUSTRY REQUIREMENTS

To work as an Occupational Therapist in the UK, the person must hold a recognised degree or a post-graduate diploma in Occupational Therapy and be registered with the Health Professions Council (HPC). This is a requirement for the non-statutory sector as well as the Health and Social Care sector.

REGISTRATION WITH A PROFESSION AL PODY

The title Occupational Therapist is protected by anyone practicing Occupational Therapy in the UK must be registered with the H.C. This register is on-line at http://www.hpc-uk.org/index.ap.. Arolloans who qualified outside the UK must submit an application to HPC international agreement who asses if their qualifications meet the standards of proficiency and are therefore equivalent to UK standards, Only EEA Nationals will be offered a period of adaptation training. CASEWORKER TREATMENT

B&C

The job of Compational Therapist meets the skills criteria. Caseworkers should check the overseas national is registered with the HPC. If the Occupational Therapist in the UK undertaking a test of competence (see Annex 1), caseworkers should conditionally approve the permit by adapting paragraph P70H, pending the submission of the Occupational Therapist's registration number. TWES

Training

This occupation does not meet the TWES criteria for training.

Work Experience

This job is suitable for work experience when the OSN is HPC registered.

SALARY

Occupational Therapists employed by local councils (Social Service Departments or Social Work departments) have their own pay scales. These are all determined by individual councils using a national framework (signal status framework). They may not reflect the Agenda for Change pay scales. Case workers should use the Agenda for Change pay scales as a general guide but should contact Policy Team for advice if the salary appears low.

Annex 1

HPC registration

Registration with HPC should take between six weeks and a few months. To receive HPC registration an individual who has been trained in the UK must attend a Degree or Postgraduate Diploma/ Master's course that has been approved by the HPC. The list of approved courses can be found on-line at www.hpc-uk.org

The Occupational Therapist must also adhere to the usual ethical standards.

If the Occupational Therapist was trained overseas they must apply to the HPC international department, who will check the applicant's qualifications, work experience and ethics are equivalent to UK standards. The HPC can suggest that they undertake a test of competence if the applicant is already in the UK. This can include an interview or clinical test of competence and should only take a few days.

EEA nationals and Non-EEA nationals who are married to EEA nationals are covered by the EU's General System Directives 89/48/EEC and 92/51/EEC (this includes Romanian and Bulgarian nationals). The Directive requires the HFC to take the applicant's qualifications from their home country in account The HFC will decide if any additional training is required. The HPC can advise that the applicant undertakes a period of adaptation. The HPC will not offer adaptation to any other non EEA applicant.
