Dear Sir/Madam

Thank you for your email of 14 November 2016 requesting the following information:

*"Could you please provide me with a list of the meeting places farms or buildings provided to you by hunts for December operating on Salisbury Plain. Training Area for the 2016/2017 season. This should not be a problem as similar information is provided by other Government bodies such as the Forestry Commission and the national Trust for hunts taking place on land they administer"*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that some information, in scope of your request is held.

The information you have requested can be found enclosed at annex A.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that the only information that is required on meeting places under MOD hunting licenses is an area in which the hunt will be operating. Exact meet up location information is not held.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 2<sup>nd</sup> Floor, Zone N, MOD Main Building, Whitehall, SW1A 2HB (e-mail [CIO-FOI-IR@mod.uk](mailto:CIO-FOI-IR@mod.uk)). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
