## **AUTHORIZED AMENDMENT**

Issue 6 of RA 1024 represents minor amendments to Issue 5 following significant engagement with stakeholders. More specifically, Issue 6: introduces the Military Permit to Fly (MPTF); permits Accountable Managers (Military Flying) (AM(MF)) to approve post-holders (vice the MAA); and emphasizes that AM(MF)s may also be post-holders.

Issue 2 of RA 1028 represents minor amendments to the initial RA following significant engagement with stakeholders. Issue 2 also makes it clear via the regulatory statement that Contractor Flying Approved Organization Scheme (CFAOS) organizations shall comply with the MAA Regulatory publications (MRP), and introduces the MPTF.

Issue 3 of RA 2501 represents minor amendments to Issue 2 following significant engagement with stakeholders. More specifically Issue 4 introduces the MPTF and requires CFAOS organizations to provide the MAA with copies of current and up-to-date Contractor Flying Organization Expositions.
