Thank you for your email of 16 February 2016 requesting the following information:

"The information I request is as follows:

- 1. Most recently dated survey conducted including detailed floor plan showing room measurements.*
- 2. Most recent dated energy efficiency certificate and rating awarded.*
- 3. Most recent dated noise survey.*
- 4. Date Kitchen was completely renewed, detailing what was renewed.*
- 6. Date Bathroom suite was renewed.*
- 7. Date Windows were renewed including when they were last resealed.*
- 8. Renewal of carpets, detailing when each individual room was refitted.*
- 9. Most recent date Kitchen and bathroom flooring was renewed.*
- 10. Date Boiler was replaced.*
- 11. Date central heating system was refitted/renewed/serviced.*
- 12. Date that toilet was renewed.*
- 13. Date all radiators were renewed.*
- 14. Date and details of all repairs conducted over the last 20 years (since 2005).*
- 15. Latest Date insulation including interior linings were renewed in attic.*
- 16. Latest Date that exterior guttering was renewed.*
- 17. Latest Date that exterior roof was re-tiled.*
- 18. Most recent date that all ventilation was renewed.*
- 19. Most recent date extractor fans were renew in kitchen (2) and bathroom (1).*
- 20. Most recent date exterior and interior doors were renewed including when they were last resealed and rehung.*
- 21. Most recent fire safety inspection certificate.*
- 22. Dates of installation of fire doors throughout the property.*
- 23. Dated that smoke alarms were fitted and most recent date of inspection.*
- 24. Details of when the property was last completely redecorated detailing what work was completed."*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that some of the information in scope of your request is held.

The information you have requested can be found attached but some of the information falls entirely within the scope of the absolute exemptions provided for at [sections 40 (Personal Data) of the FOIA and has been redacted.

Section 40(2) has been applied to some of the information in order to protect personal information as governed by the Data Protection Act 1998. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
