Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 26 October 2015.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert the part of bridleway A32 which extends from a point situated approximately 20 metres south east of the Grand Union Canal at Grid Reference 46958 29092 in a generally south easterly direction across a large agricultural field and through a small holiday park for a total distance of approximately 740 metres to a point situated approximately 30 metres north west of North Lane, Foxton at Grid Reference 46996 29031.

The alternative route will extend from Grid Reference 46958 29092 in a generally south westerly direction along the western boundary of the large agricultural field for a distance of approximately 375 metres to a point situated by the south western corner of the field at Grid Reference 46944 29059 and then continue in a generally east-south easterly direction along the south western boundary of the field for a further distance of approximately 590 metres to Grid Reference 46996 29031 as shown on the Order Map.

Within 2 weeks of the start date [by 9 November 2015]

Within 8 weeks of the start date [by 21 December 2015]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 1 February 2016]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.
