### PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about media licenses, which we received on 8 February 2016. Your request has been handled under the Freedom of Information Act 2000.

The information you requested and our response is detailed below:

"I am writing to you under the Freedom of Information Act 2000 to request the following information from Animal Health and Veterinary Laboratories Agency:

- Did the Animal Health and Veterinary Laboratories Agency pay for a NLA (Newspaper Licensing Agency) or CLA (Copyright Licensing Agency) media license in 2013-2014?
  - Yes, the Animal and Plant Health Agency (APHA), formerly the Animal Health and Veterinary Laboratories Agency (AHVLA), did pay for a NLA (Newspaper Licensing Agency) or CLA (Copyright Licensing Agency) media license in 2013-2014.
- If so, how much did the Animal Health and Veterinary Laboratories Agency pay for the licenses in 2013-2014 (please provide the figures separately)?
   Between April 2013 and March 2014, the Animal and Plant Health Agency (APHA), formerly the Animal Health and Veterinary Laboratories Agency (AHVLA), paid £3,763.08 for a NLA license.

Between April 2013 and March 2014, the Animal and Plant Health Agency (APHA), formerly the Animal Health and Veterinary Laboratories Agency (AHVLA), paid £11,587.20for a CLA license.

 Did the Animal Health and Veterinary Laboratories Agency pay for other media licenses in 2013-2014? Please list any other media licenses the council subscribed to and how much was paid for them in 2013-2014."
 No, the Animal and Plant Health Agency (APHA), formerly the Animal Health and Veterinary Laboratories Agency (AHVLA), did not pay for other media licenses in 2013-2014.
