The following notice gives notice of the surrender in part of an environmental permit.

The part of the environmental permit that has been surrendered is an area of land on the western edge of the site. This land was occupied by the main site office, car parking facilities, diesel, oil and lubricant storage and the site weighbridge. The land has never been used for the permanent deposit of waste. All infrastructure has now been removed and the land has been fully restored in accordance with the extant planning permission.
