In accordance with Section 1(1)(a) of the Act I hereby confirm that the CNC/CNPA does hold information of the type specified.

Training requirements are unclear at this time due to changes of outsourcers. However it is expected that contract/supplier management, ITIL and other non-technical management courses would be required.

Q5 Can I have a list of any ICT software Upgrades planned for the new financial year? The software upgrades planned are for the line of business applications only this FY.

Q6 Can I have a list of any hardware upgrades planned for the new financial year? These are already underway and cover changes from Windows Server 2003 and networking hardware as required.

Q7 Can you provide copies or details of any ICT projects?

We have a proposed IT Modernisation programme that will change from a single outsourcer to a multiple supplier model. This will change our office/email systems and possibly hosting mechanisms.
