M4 Junctions 3 to 12 Smart Motorway Pre-application consultation between 10 November and 21 December 2014

I am writing regarding the M4 junctions 3 to 12 smart motorway scheme.

The Scheme would improve the M4 Motorway between Junction 3 (Hayes) and Junction 12 (Theale) to a smart motorway. The Scheme extends over a distance of approximately 50 km. The Scheme includes permanently converting the hard shoulder to a running lane (referred to as All Lane Running) and using technology to vary speed limits and manage traffic. Signs and signals will be used to inform drivers of conditions on the highway network, when and where variable mandatory speed limits are in place, and when lanes are closed. There are a number of hard shoulder discontinuities on the M4 between Junction 4 and Junction 8/9 where existing bridges over or under the M4 limit the available carriageway width. It is proposed that these bridges are widened, or demolished and rebuilt, in order to enable All Lane Running along the Scheme. The aims of the Scheme include: relieving congestion and smoothing the flow of traffic; and improving journey times and journey time reliability.

The Highways Agency is seeking development consent for this improvement scheme under the Planning Act 2008 ("the Act"). This legislation requires the Agency to make an application for a Development Consent Order ("DCO") to construct the proposed scheme to the Secretary of State for Transport. We intend to make the application for development consent in early 2015. In advance of that application, we are undertaking public and stakeholder consultation on the proposed scheme until Sunday 21 December 2014. We are consulting you as we believe you may have an interest in the proposed scheme. We have produced a number of documents to assist consultees to respond to this consultation. A copy of the following documents:

- a) Consultation brochure;
- b) Preliminary Environmental Information ("PEI") Report and its Non-Technical Summary;
- c) Planning Act Factsheet;
- d) The Statement of Community Consultation and Section 48 Notice;
- e) Questionnaire; and
- f) Proposed scheme drawings
