This table indicates the derivation of provisions in the 2016 Rules. The 2016 Rules broadly derive from the 1986 Rules and forms. However there is rarely an exact match as the structure of the 2016 Rules is different, the language has been modernised and there have been significant changes, in particular as a result of amendments to the primary legislation made by the Enterprise and Regulatory Reform Act 2013, the Deregulation Act 2015, and the Small Business, Enterprise and Employment Act 2015. Furthermore the information requirements previously contained in forms have now been imported into the relevant rule as specified content. Finally the new Rules try to avoid copying out of the primary legislation. Instead they contain many references to Insolvency Act 1986 to enable the user to connect individual rules with the relevant provisions of the Act that the Rules supplement.
