Thank you for your email of 30 September 2016 requesting the following information:

"I am writing to submit a request for information from the Ministry Of Defence Guard Service (MGS) under the Freedom Of Information Act 2000.

On the 7th June 2015, MGS Security Officer, CSO5 submitted a report and 'Near Miss' reporting form to his supervisor, CSO3 1. The reports, which were submitted via email were entitled 'Near Miss With Military Working Dog '.

On the 12th June 2015, and received a reply (email) from the Defence Infrastructure Organisation (DIO) entitled '20150612 For Action By 19th June 2015'.

The report and subsequent replies/actions are in relation to injuries recently sustianed by MOD security guards and police officers, myself included. I respectfully request a copy of both the initial email and report submitted by and the subsequent final report or 'action' from DIO, and any other attached information/comments/investigations regarding the near miss made by relevent parties."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all the information in scope of your request is held.

The information you have requested can be found enclosed at Annex A, but some of the information falls entirely within the scope of the absolute exemption provided for at Section 40 (Personal Data) of the FOIA and has been redacted.

Section 40(2) has been applied to some of the information in order to protect personal information as governed by the Data Protection Act 1998. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 2nd Floor, Zone N, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed. Further details of the role and powers of the Information Commissioner can be found on the Commissioner's website, http://www.ico.org.uk.

As this is a near miss it must be treated as such and reported in the correct manner to DIO CESO etc. However, I am more concerned having taken an interest in the Dogs for over 10 years now that there is a perception that handlers are getting a little too blasé when around their animals and that dogs are not supposed to bite. The good guard dogs are the keen ones that will bite, that is what we train them to do. Our dogs are not pets or police dogs, effectively they are attack dogs. seems to be getting a bit of a bad press for doing what he is trained to do...bite. What I don't want is those outside of the dog world getting too "PC" or over cautious over incidents which could be down to "handler error". That said of course, if we have a dangerous dog we must deal with it, but there is a balance and it is not the same balance as out side the PAT Dog world.

Being caught or carried away by something (or by momentum) - Body movement without physical stress, generally leading to an external injury. Covers the concept of being carried by ones own momentum, so as to bring a part of the body into contact with a Material Agent which causes an injury.

Breakage, bursting or collapse of material - Breakage of material - at joint, at seams, Breakage, bursting - causing splinters (wood, glass, metal, stone, plastic, others)

Slip, fall, collapse of Material Agent - from above (falling on the victim), from below (dragging the victim down), - on the same level, Slip, fall, collapse of Material Agent.

Electrical problem, explosion or fire - Electrical problem due to equipment failure leading to indirect contact - Electrical problem leading to direct contact, explosion, Fire, flare up

Kneeling, sitting or leaning on an object - Body movement without physical stress, generally leading to an external injury. An example is the injured person injuring his knee on an open desk drawer while sitting down.

Lifting, carrying, standing up Body movement under or with physical stress, generally leading to an internal injury..

Loss of control of machinery, transport or equipment - Loss of control (total or partial) - of machine (including unwanted start-up) or of the material being worked by the machine - Loss of control (total or partial) - of means of transport or handling equipment, (motorised or not)

Overflow, leak, vaporisation or emission of liquid, soil or gaseous product - Solid state - overflowing, overturning Liquid state - leaking, oozing, flowing, splashing, spraying

Subject: Near miss with MWD

I've previously pointed out a change to behaviour since his bite on MDP to my colleagues, whereby he has been attempting to nip my hand when I've been putting the feed bowl in. This has pitted out recently, but this morning at 7am while trying to hook him up after putting my left hand in his collar he snarled at me then attempted to bite aggressively at my right hand, I managed to pull it away before he did. He calmed down immediately after.

I've been bitten in the past by my own dog, but this has always been due to the dog having underlying health problems, has been checked out at the vets and nothing found to be wrong with him. I've reported this as a near miss through what I think are the correct channels to yourselves and <u>DIO-CESO</u>
