FREEDOM OF INFORMATION REQUEST - DARTFORD CROSSING

Thank you for email dated 21 June 2015 under the terms of the Freedom of Information Act 2000. The specific details of your request have been extracted from your email and are highlighted in bold with our responses below.

1. How many vehicles have crossed the river at Dartford?

For period covering this request - 30 November 2014 to 20 June 2015, there were 27,700,681 vehicle passages recorded at the Dartford Crossing. Of this, 24,418,617 occurred within the chargeable hours 6am – 10pm.

2. How much revenue has been generated through the Charge?

Since the start of free-flow operation at the Dartford crossing i.e. for the period 30/11/14 – 31/05/2015, £49,947,843.37 has been collected through the road user charge.

3. How many Penalty Notices have been issued?

For the period of the request, we can confirm that 953,067 Penalty Charge Notices (PCNs) have been issued.

4. How many of the Penalty Notices were wrongly issued?

When we issue penalty notices, we do so because we have genuine grounds to believe that a customer has not paid for their crossings. We can confirm that there have been 8,834 PCNs cancelled due to service provider error.

5. What was the cost of issuing the wrongly issued Penalty Notices?

The precise detail as to the costs of issuing a single PCN is encompassed within a variable transaction cost included in the overall running costs of the scheme. We are therefore unable to provide an individual figure for this and consequently we are unable to work out the cost as per your question.

6. How much revenue was generated by the Dartford crossing in the 5 years prior to the introduction of the Dart Charge?
