The A14 Trunk Road (Junction 25 Hemingford Abbots, Cambridgeshire to Junction 37 Exning, Suffolk), the A428 Trunk Road (Girton Interchange) and the M11 Motorway (Junction 11 to Junction 14) (Cambridgeshire) (Temporary Restriction and Prohibition of Traffic) Order 2015 Variation Order 2015

Highways England Company Limited(a), makes the following Order in exercise of the powers conferred by section 14(1)(a) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(b).

This Order may be cited as the A14 Trunk Road (Junction 25 Hemingford Abbots, Cambridgeshire to Junction 37 Exning, Suffolk) the A428 Trunk Road (Girton Interchange) and the M11 Motorway (Junction 11 to Junction 14) (Cambridgeshire) (Temporary Restriction and Prohibition of Traffic) Order 2015 Variation Order 2015.

1. The A14 Trunk Road (Junction 25 Hemingford Abbots, Cambridgeshire to Junction 37 Exning, Suffolk) the A428 Trunk Road (Girton Interchange) and the M11 Motorway (Junction 11 to Junction 14) (Cambridgeshire) (Temporary Restriction and Prohibition of Traffic) Order 2015 (c) is hereby varied by substituting, for the definition of “a works period” in article 2, the following definition –

“a works period” means a period of –

- (a) 10 hours starting at 20.00 hours on Monday 9th November 2015 or on any subsequent day, or
- (b) 58 hours starting at 20.00 hours on Friday 22nd January 2016 or on any subsequent Friday, until the works have been completed;

NOTICE IS HEREBY GIVEN that Highways England Company Limited (a) has varied the existing Order on the A14 and A428 Trunk Roads and the M11 Motorway, in the Counties of Cambridgeshire and Suffolk, which was made to allow for carriageway resurfacing, safety fence improvements, associated works and routine maintenance to be carried out in safety.

The Order varied is The A14 Trunk Road (Junction 25 Hemingford Abbots, Cambridgeshire to Junction 37 Exning, Suffolk) the A428 Trunk Road (Girton Interchange) and the M11 Motorway (Junction 11 to Junction 14) (Cambridgeshire) (Temporary Restriction and Prohibition of Traffic) Order 2015/1599.

The effect of the Order will be to include an additional works period of 58 hours starting at 8pm on Friday 22 January 2015, to allow for 5 consecutive weekend closures of the M11 Junction 13 northbound exit slip road, and a single weekend closure of the A1307 Huntingdon Road.

The Order will come into force on 14 December 2015 and continue until the works have been completed.
