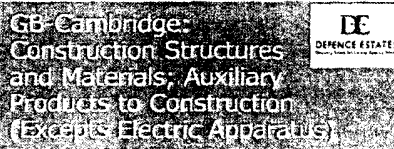

Construction structures and materials; auxiliary products to construction (excepts electric apparatus). Ascension Island is located just south of the equator in the South Atlantic Ocean and is part of a single territorial grouping under the sovereignty of the British Crown. The island is a dependency of St Helena which lies some 800 miles to the southeast. The nearest continental land is Cape Palmas in Liberia which is approximately 900 miles to the north-north-east. The island is roughly triangular, 7 miles from north to south and 8.5 miles from west to east covering an area of approximately 37.5 square miles. The geology is volcanic with an extremely rugged topography. The western part of the island is relatively low lying and dry, while the eastern end is higher and moister, rising to an altitude of 859 m at the summit of Green Mountain.

The Petroleum Supply Depot (PSD) on Ascension Island is located at Catherine Point, approximately 0.5km south west of the capital Georgetown. The PSD was originally built by the United States in the 1950's, and is now operated and maintained by the UK Ministry of Defence (MoD). The site underwent a major upgrade in 2001

The site comprise 9 No. existing fuel storage tanks, 7 No. holding AVTUR (aviation turbine fuel - F35) and 2 No. holding ULGAS (unleaded petrol - F67).

The works under this requirement comprise the following.

- Decommissioning and demolition of 1 No. 1.2 million (M) litre (l) AVTUR tank
- Design and construction of new 6.0M (useable capacity, 6.4M total capacity) AVTUR tank, within the footprint of tank previously demolished, including the following associated infrastructure:
  - o new bunding,
  - o pipework to connect the new tank to the existing fuel supply and receipt systems,
  - o pipework to connect the new tank to the existing drainage system,
  - o control and monitoring systems,
  - o fire suppression
  - o lightning protection,
  - o cathodic protection
  - o Flood lighting to the perimeter of the tank.
- Upgrade of existing fire suppression system (subject to assessment of existing capabilities).
- Decommissioning and demolition of a further 2 No. 1.2M AVTUR tanks.

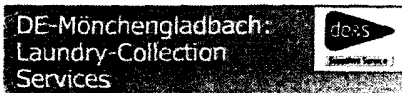
