**Description of change:**

1. The exclusion appeal result data item <AppealResult> (100096) is no longer in use and Policy have requested that the item be removed from CBDS to avoid potential confusion.
2. Codeset D00262 Nation states and countries was rolled forward from codeset D00242 and from codeset D00008. On initial roll forward, the country of Slovakia was omitted from the codeset. This update corrects this omission by 'adding back' Slovakia to the dataset.
