# Information released under the Freedom of Information Act

Title: Secondments into the Department

#### Date of release: 6 March 2015

#### Information request

My request relates to personnel from external organisations who have been seconded to work at the Department for Business, Innovation and Skills.

For each of these secondees, I would like to ask:-

- 1. their full name;
- 2. their job title;
- 3. the name of the organisation or body they have been seconded from;
- 4. the group, directorate or branch of your department they work in;
- 5. a brief description of their area of responsibility whilst on secondment to the department;
- 6. the position of the official within your department to whom the secondee reports;
- 7. the dates on which they started the secondment;
- 8. the dates on which they ended their secondment;
- 9. whether the department makes a contribution towards the salary of the secondee.

#### Information released

I can confirm that the Department does hold the information you have requested. Details of job titles of the secondees into our Department are not held centrally. We estimate that complying with this part of your request would exceed the cost limit of £600 provided under Section 12 of the Freedom of Information Act. This represents the estimated cost of spending 3.5 working days: (i) determining whether the department holds the information, and (ii) locating, retrieving and extracting the information. The Act provides that we are not obliged to comply with requests where the estimated cost of complying would exceed this limit. In order to find this information would mean contacting each relevant management unit to determine if this information is held. We estimate that it will take us in excess of 3.5 working days to determine if appropriate material is held and to locate, retrieve extract the information in reference to your request. Therefore,

this part of your request will not be processed further at this time. You may wish to consider refining this part of your request by narrowing its scope such as for a shorter timescale or for fewer secondees.

In terms of payment of salary for secondments into our Department, our policy is that we re-imburse their employer.

BIS considers the names of secondees working at a level below that of the Senior Civil Service (SCS) to constitute personal data and therefore this has been withheld. Section 40 of the Act provides an absolute exemption for personal data which then falls to be dealt with under the Data Protection Act. Personal data of third parties can only be disclosed in accordance with the data protection principles. In particular, the first data protection principle requires that disclosure must be fair and lawful and must comply with one of the conditions in Schedule 2 of the Data Protection Act. We do not think that it is fair to release the names of staff working below the level of SCS and do not think that any of the relevant conditions apply.

The information, drawn from our central HR system, is attached as Annex A below.
