Thank you for your email received by the Ministry Of Defence on 23 November 2016 requesting the following information:

- · Number of personnel for each rank of the RAF:
- o Commissioned Ranks (MRAF, Air Chief Marshal, Air Marshal, Air Vice-Marshal, Air Commodore, Group Captain, Wing Commander, Squadron Leader, Flight Lieutenant, Flying Officer, Pilot Officer)
 - o Non-Commissioned Ranks (Warrant Officer, Flight Sergeant, Chief Technician, Sergeant)

If possible, could I also obtain the stats for the equivalent ranks for the Army and the Royal Navy?

We are treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

We have now completed a search for the information you requested and I can confirm that all information in scope of your request is held.

Under **Section 21** of the FOIA (Information Reasonably Accessible to the Applicant by Other Means), figures for UK Regulars split by NATO Rank from 2012 to 2016 are available in Table 11a of the Excel Workbook which forms part of the Monthly Service Personnel Statistics publication, available at: https://www.gov.uk/government/uploads/system/uploads/attachment_data/file/569204/Monthly_Service_Personnel_Statistics_1October16.xlsx

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
