INTRODUCTION

Purpose of the Wales Office

The Wales Office supports the Secretary of State for Wales in promoting the best interests of Wales within a stronger United Kingdom. It ensures Welsh interests are fully and effectively represented at the heart of the UK Government, and the UK Government's responsibilities are fully and effectively represented in Wales.

The Wales Office also supports the Secretary of State in ensuring the smooth working of the devolution settlement in Wales.

Our vision is for a more prosperous, ambitious and fairer Wales. We will achieve this by working in partnership with colleagues in Whitehall, the Welsh Government and others across the public, private and third sectors.

We continue to be Wales' voice in Westminster and Westminster's voice in Wales.

Values

The Wales Office conducts its business with courtesy, efficiency, effectiveness and propriety, and in accordance with its core values. They are to:

- secure the best deal for Wales, which remains our overriding priority and shapes every aspect of our work;
- deliver excellence and quality in everything that we do;
- support and develop our staff, and ensure they have a safe working environment; and
- be open and transparent, and work in partnership with others.

We demonstrate these values by:
