

## **Invitation to Tender for 2015 Duty Provider Crime Contracts**

## Amendment Notice with effect from 14 April 2015

On 27 November 2014 we published on our eTendering portal the Invitation to Tender for 2015 Duty Provider Crime Contracts.

In accordance with paragraph 8.12 of the Information for Applicants, ("IFA") Applicant Organisations are notified that we have corrected minor errors in the Duty Provider procurement process and IFA by:

- correcting the information given in Annex B Table 3: Procurement Area Rules
   and schemes covered by each Procurement Area' regarding Magistrates' court
   schemes operating in the Brent, Croydon, Enfield, Greenwich and Lewisham
   (Greenwich and Woolwich), Hammersmith and Fulham (West London), Lambeth
   (Camberwell Green) and Newham Procurement Areas; and
- <u>publishing a new version of the Established Business Financial Assessment</u> <u>Form</u> to correct a small technical error.
