Thank you for your email of 26 January 2015 which requested the following information:-

- "1) How many Tornado sorties did Britain conduct over Iraq between 1 October 2014 and 26 January 2015;
- 2) How many Tornado strikes did Britain conduct over Iraq between 1 October 2014 and 26 January 2015;
- 3) How many of these Tornado strikes resulted in the delivery of ordnance to targets;
- 4) What has been the total cost to date of Tornado operations against ISIS;
- 5) How many Reaper UAV sorties has the UK conducted over Iraq;
- 6) How many of these Reaper UAV strikes have resulted in the delivery of ordnance to targets;
- 7) Beyond special forces, how many British military personnel are currently stationed abroad for the purposes of training the Kurdish peshmerga:
- 8) What has been the total cost to date of British military operations against ISIS"

Your correspondence has been treated as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and we can confirm that most of the information in the scope of your request is held.

The information you have requested can be found below, but some of the information falls entirely within the scope of the qualified exemption provided for at section 22 (Information intended for future publication) of the FOIA and has been withheld.

Section 22 is a qualified exemption and is subject to public interest testing which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure.

Section 22 has been applied to questions 4 & 8 because costs are still being collated and will be published in the MOD's Annual Report and Account due later this year.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
