Thank you for your email of 2 July 2016 which requested the following information:-

"Date, time, location (preferably latitude and longitude), and type (e.g. Predator + model) of all UK drone (UAVs or RPAS) strikes in Syria since strikes were authorised in 2015. For each strike: the number and type of missiles dropped."

Your correspondence has been treated as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and we can confirm that all the information in scope of your request is held and some can be found below. However, an element of your request seeking detail on specific location and time falls within the scope of the qualified exemptions under section 26 of the FOIA and has been withheld.

Section 26 (Defence) is a qualified exemption and is subject to a public interest test, which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure.

Section 26(1)(b) has been applied to some of the information because it contains details which are operationally sensitive which contribute to the effectiveness of air operations, and which would prejudice the capability and effectiveness of our armed forces. The balance of public interest was found to be in favour of withholding the information, given that the public interest is best served in not releasing any details of Reaper strikes as it would provide tactical advantage to our enemies.
