Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

The requirements of the Industrial Emissions Directive (IED) 2010/75/EU are given force in England through the Environmental Permitting (England and Wales) Regulations 2010 (the EPR) (as amended).

This variation notice refers to the operation of large combustion plant (LCP), as defined by articles 28 and 29 of the Industrial Emissions Directive (IED). Environmental Permit EPR/EP3938CP has been varied by the Environment Agency to facilitate the implementation of the special provisions for LCP given in the IED, by the 1 January 2016 (Article 82(3)). The IED makes special provisions for LCP under Chapter III.

This variation notice sets condition 1.1.3 into Environmental Permit EPR/EP3938CP to ensure that the site can only operate in accordance with Chapter III of the Industrial Emissions Directive. The Operator, Iggesund Paperboard (Workington) Limited, must demonstrate their compliance with Chapter III of the Industrial Emissions Directive, should they wish to operate the site and must have obtained written approval from the Environment Agency before operating.

The CHP comprises principally a gas turbine, rated at 110MW net thermal input, with a Heat recovery Steam generator (HRSG) and a steam turbine. The CHP is designed to deliver 49MW of electricity and up to 92MW of process steam.

This introductory note also confirms the updated LCP numbers in accordance with the most recent DEFRA LCP reference numbers. The LCP references have changed as follows:

- LCP 171 is changed to LCP 184 which is set in reference to the CHP plant (110MWth); and
- LCP 172 is changed to LCP 185 which is set in reference the standby plant/boilers (161MWth).

The schedules specify the changes made to the original permit.
