### 1. Welcome, Apologies and Declarations of Interest

Apologies were noted from Professor Martin Severs and Cameron Robson.

# 2. Update from the Department of Health Sponsor

Katie Farrington provided an update on the final preparatory work being undertaken on the National Data Guardian's Review. Katie stated that the Review report was currently with the Secretary of State and a date for publication was yet to be confirmed. Katie advised that the report was going through the final stages of proof-reading in advance of publication.

The Chair and her Panel agreed on the importance of a public engagement following the publication of the report.

## 3. National Data Guardian's Office update

Simon Gray informed members about the recent production of the NDG Office's Information Management policy, and advised that this had been supported by the NDG's Steering Group at their last meeting in March. Simon advised that the new policy will be rolled out over the coming months and also gave an update on the introduction of NDG email addresses.

### 4. Data Access Consultation

The Panel discussed the Cabinet Office Data Access Consultation. Panel members were asked to submit their comments in order for a consolidated response to be considered at the next NDG's Steering Group meeting in April.

Action 4.2: Simon Gray to draft a response to Data Access Consultation on behalf of the Panel which will be discussed at the next Steering Group meeting on 14<sup>th</sup> April 2016.

#### 5. Creation of Council of Data Ethics

The Panel considered a paper written by member James Wilson regarding the establishment of a Council of Data Ethics.

### 6. Cancer Registries

Michael Chapman from Cancer Research UK and Julie Flynn from Macmillan Cancer Support attended to discuss their proposal to conduct a rapid review as to how cancer patients should be informed about the use of their data in cancer registries.
