FREEDOM OF INFORMATION ACT 2000 REQUEST REF: 0925-14

Thank you for your request for information under the Freedom of Information Act (FOIA) 2000 which we received on 1 October. You asked:

What was the total cost of human rights training (for the Iraqi defence and security forces) contracts delivered by/facilitated by the UK in Iraq 2007-2009?

I am writing to confirm that we have now completed the search for the information which you requested. I apologise for the delay in responding. Section 27(1)(a) of the FOIA recognises the need to protect information that would be likely to prejudice relations between the UK and other states if it was disclosed. While we considered withholding some information under this provision, we decided that it was not relevant in this case.

The Foreign and Commonwealth Office does not hold a breakdown of costs relevant to this request. The information we have found below in italics, however, provides some information on projects supported by the UK in this period. I hope this is of some assistance.

UK STRATEGY FOR SECURITY AND JUSTICE SECTOR REFORM (SJSR) IN IRAQ 2008-09

Summary: The UK will sustain its support to the development of security and justice sector institutions in Iraq in 2008-09. We will maintain our commitment to Basra while pursuing wider reform at the centre. SJSR will contribute directly to HMG's goal of creating an Iraq than can defend itself and provide security to its people within a rule of law based system. Available civilian funds for SJSR in 2008-09 will be over £22m. These will be drawn from the Iraq Stabilisation Fund (£16.16m), the UK Peacekeeping budget (£8m) and the MOD administrative budget. Programme work will be embedded within a political strategy aimed at leveraging structural Iraqi change and more and better international engagement. Delivery of the strategy and programmes will be managed by HMG staff at Post, with strong cross-Whitehall back-up in London.

UK INVOLVEMENT AND ADDED VALUE

The 2008-09 strategy should build on the achievements and lessons of the last four years. Our involvement has been primarily in the following areas:

- <u>FCO Basra justice assistance</u>: We have built regional and international links between the Basra judiciary and Middle Eastern centres of legal expertise and provided training in human rights, international humanitarian law and judicial independence.
- <u>FCO assistance on human rights protection and promotion</u>: We have advised the Ministry of Human Rights, supported the growth of civil society groups and providing human rights awareness training to all sectors of the Iraqi criminal justice system.
- <u>DFID judicial training</u>: 216 Iraqi judges, lawyers and prosecutors trained in human rights, international humanitarian law, and independence of the judiciary.
