# Written examination dates 2014/15: Engineer officers (yachts and sail training vessels)

Notice to all owners, masters, engineer officers and crews of commercially operated yachts, large private yachts and sail training vessels and those concerned with maritime training

This notice replaces MIN 461 (M) from 1 September 2014 This MIN expires 31 August 2015

#### Summary

This notice sets out the written examination dates for Engineer Officer Certificates of Competency (limited to yachts and sail training vessels) for the academic year commencing 1 September 2014.

Only the dates for the Yacht 2 General Engineering Science I and II examinations are set. All other papers will be on demand at the request of a training provider giving a minimum of 14 days notice.

#### 1. Introduction

- 1.1 In accordance with the Maritime and Coastguard Agency (MCA) Large Commercial Yacht Code (LY2)¹, it has been agreed with industry that Certificates of Competency will be issued for service as Engineer on commercially operated yachts, large private yachts and sail training vessels. A Marine Guidance Note explains the background, and application requirements and procedures. Currently that is MGN 156 (M).
- 1.2 Some examination titles changed from September 2005 due to revision and updating of the syllabuses. The syllabuses are available on the MCA website under Working at Sea/Training and Certification/Yachts/Yachts syllabus.
- 1.3 The examinations are administered by the Scottish Qualifications Authority (SQA) on behalf of the MCA and are held at their examination centres in the United Kingdom, or by special arrangement at overseas centres. The written examination dates for the academic year commencing 1 September 2014 have been agreed following consultation with various representative organisations of the yachting industry. Annex 1 sets out the pattern of written examinations to be held between 1 September 2014 and 31 August 2015.
