

# Hospitalar, Brazil 16 – 19 May 2017

Healthcare UK and the Department for International Trade are organising a trade delegation of British Digital Health organisations to Hospitalar 2017.

The mission will be led by NHS Digital's Director of Digital Transformation, Beverley Bryant and feature around 10 of the most innovative organisations in the healthcare technology space. We would like to invite expressions of interest from private and public bodies who would like to join the delegation.

#### Why you should join

Hospitalar is the key event for the healthcare sector in the Americas, and entry point for the South American market. It is the largest healthcare trade show in Latin America, attracting over 90,000 professional attendees with 50 talks, seminars, workshops and meetings focused on healthcare.

The Brazilian healthcare market is the largest in Latin America, with a total spend of US \$195.7 bn in 2014. The public healthcare system (SUS) is based on the NHS system and provides universal coverage, free at the point of use for over 200 million people. Brazil has a high growth rate in the over-60 population, indicating that a huge potential market exists for health products and services.

The private healthcare sector has significant purchasing power, providing coverage to around 50 million people and an annual expenditure of US \$103 bn. A recent change to Brazilian law, allowing for foreign capital investment in healthcare is driving growth in the private sector with Bupa acquiring the leading Brazilian insurer Care Plus and United Health Group acquiring Amil last year.

The current Health IT market size is estimated at between US \$500 million and \$1 billion with significant growth forecasted. The health app market in Brazil is expected to reach \$46.6 million by 2015 and a national plan for investing in EHR development country-wide across all levels of government will lead to significant commercial opportunities for overseas organisations.


