As I advised in my letter dated 14th March 2016, the MOD does not have any current contracts with Adam Smith International, Albany Associates, Crown Agents, DAI Europe Ltd, Oxford Policy Management, Saferworld, Sovereign Global, The HALO Trust, The Risk Advisory Group and Viasol Limited.

The information against one contract has been withheld under qualified exemption Section 26(1)(b), of the FOIA. As advised in my letter of 14th March 2016, a Public Interest Test (PIT) was undertaken to determine whether, in all circumstances, the public interest in maintaining the exemptions outweighed the public interest in disclosure. The PIT weighed the presumption of disclosure and the enhancing of public accountability against whether reference to projects and systems could place at risk the capability, effectiveness or security of the Armed Forces.

The PIT concluded that for all but one contract there were no grounds to withhold contract information. In the single case, however, it was considered that reference to a sensitive system could impact on the security of Armed Forces. It was considered, therefore, that the balance of the public interest was in maintaining the qualified exemption and withholding the information under Section 26(1)(b) of the FOIA. The level of prejudice was considered to be 'would be likely to'.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
