REQUEST FOR INFORMATION: BADGER CULL 2015 TESTING

Thank you for your request for information, which we received on 15 October 2015, asking if any tests or post mortems were undertaken on badgers during the 2015 badger cull and whether any showed evidence of visible lesions. We have interpreted your request as referring to lesions caused by bovine TB.

We have handled your request under the Freedom of Information Act 2000 (FOIA) and apologize for the delay in replying to you.

No badgers were tested for TB or examined specifically for TB lesions during the 2015 culls. A small number of carcases from badgers culled by controlled shooting in Dorset underwent post-mortem examination to assess rifle injuries. As this type of post-mortem examination was not designed to look for TB lesions the information that you have requested as to whether any badgers showed evidence of visible lesions is not held.

Information disclosed in response to this FOIA request is releasable to the public. In keeping with the spirit and effect of the FOIA and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
