Executive Summary

The purpose of this document is to provide an overview of the likely structure of Tier 1 Sub Contracts and Tier 2 Sub-Contracts applicable to the Project Phase "Structure", together with a description of the major relevant components and services within each of the contracts to be supplied. Tier 1 Sub-Contracts are sub-contracts during the Execute phase of the PCCS project which will be contracted by the Developer. Tier 2 Sub-Contracts are sub-contracts that will be contracted by the Tier 1 Sub-Contractors during Execute and Tier 3 Sub-Contracts are sub-contracts that will contracted by the Tier 2 Sub-Contractors during Execute.

This report provides a description of the:

- i. Structure, and;
- ii. Components for each of the identified contracts within the Structure.

Appendix 1 illustrates how the major components and services are envisaged to be procured from the supply chain.

Reference should be made to the Scope of Work for Execute Contracts – KKD 11.058 [1] which provides an overview of the technical scope of work to be carried out for the Peterhead Carbon Capture and Storage project during the Execute project phase and in particular describes how it is intended this work will be contracted.



1. Introduction

1.1. Project Introduction

The Peterhead CCS Project aims to capture around one million tonnes of CO₂ per annum, over a period of up to 15 years, from an existing combined cycle gas turbine (CCGT) located at SSE's Peterhead Power Station in Aberdeenshire, Scotland. This would be the world's first commercial-scale demonstration of post-combustion CO₂ capture, transport and offshore geological storage from a gas-fired power station.

As the Goldeneye gas-condensate field has ceased production, the production facility will be modified to allow the injection of dense phase CO₂ captured from the post-combustion gases of Peterhead Power Station into the depleted Goldeneye reservoir.

The CO₂ will be captured from the flue gas produced by one of the gas turbines at Peterhead Power Station (GT13) using amine-based technology provided by Cansolv (a wholly-owned subsidiary of Shell). After capture the CO₂ will be routed to a compression facility, where it will be compressed, cooled and conditioned for water and oxygen removal to meet suitable transportation and storage specifications. The resulting dense phase CO₂ stream will be transported direct offshore to the wellhead platform via a new offshore pipeline which will tie in subsea to the existing Goldeneye pipeline.

Once at the platform the CO₂ will be injected into the Goldeneye CO₂ Store (a depleted hydrocarbon gas reservoir), more than 2 km under the seabed of the North Sea. The project layout is depicted in Figure 1-1 below:

1.2. Supply Chain Structure

The purpose of this document is to provide an overview of the likely structure of Tier 1 Sub Contracts and Tier 2 Sub-Contracts applicable to the Project Phase "Structure", together with a description of the major relevant components and services within each of the contracts to be supplied. It should be noted that currently Shell intends to implement the project through a company known as Peterhead CCS Limited ("PCCSL").

PCCSL will submit its EPC Contracts to DECC on the basis of a suite of executed agreements, recognising that Tier 2 Sub-Contracts will only be entered into during the Execute phase of the Project should the UK government decide to proceed.

Appendix 1 provides an overview of the applicable contracts and includes:

- A brief outline of the scope of work/service;
- Whether the Sub-Contract is a Key Sub-Contract (above £50M or a component of critical importance to the Project) or a Material Sub-Contract (any Sub-Contract which is not a Key Sub-Contract entered into by PCCSL or a Key Sub-Contractor with any other person and with a value greater than ten million pounds (£10,000,000) (Indexed) or such lower amount as may be agreed in individual cases and designated by DECC as a Material Sub-Contract);
- The anticipated reimbursement mechanism; and
- Whether it is a Tier 1 or Tier 2 Sub-Contract.

The major relevant components are:

- Onshore CCCC Plant (including SSE Power station modifications);
- Landfall, Pipeline and Subsea;
- Well Engineering;
- Logistics;
- Seismic;
- Offshore Goldeneve Modifications; and
- Operations and Maintenance and Commissioning.

Supporting services for each of these components are described in Appendix 1.

Within the Project Phase Supply Chain Structure, the integration risk will be managed as follows:

- a) The appointment in the Project Execution Phase of an Integration Manager;
- b) The inclusion of appropriate terms and conditions in the EPC Contracts; and
- c) The close collaboration of the Contract holders appointed to manage each of the sub-contracts awarded.

Furthermore, the C&P Manager will have overall accountability for integrating the different contracts.



2. Conclusion

There are no unique characteristics of this Project which have required a wholesale re-think on how Shell should contract with its supply chain.
