Request under the Freedom of Information Act 2000 (the "FOI Act")

I refer to your email of **9 September** in which you requested information under the FOI Act from NHS Improvement. As you know, since 1 April 2016, Monitor and the NHS Trust Development Authority ("the TDA") are operating as an integrated organisation known as NHS Improvement. For the purposes of this decision, NHS Improvement means both Monitor and the TDA.

Your request

You made the following request:

"Under the Freedom of Information Act, please provide me with all of the data submitted by providers through the Nursing, Midwifery and Care Staff Staffing Fill Rate Indicator UNIFY Return since April 2014.

Please provide the information as a spreadsheet or CSV."

Decision

NHS Improvement holds the information that you have requested. We have decided to release all of this information to you. There is a key at Annex one which will assist you with understanding each column heading. Please note that the data in columns R,S,T and U was not available until May 2016.

Review rights

If you consider that your request for information has not been properly handled or if you are otherwise dissatisfied with the outcome of your request, you can try to resolve this informally with the person who dealt with your request. If you remain dissatisfied, you may seek an internal review within NHS Improvement of the issue or the decision. A senior member of

NHS Improvement's staff, who has not previously been involved with your request, will undertake that review.

If you are dissatisfied with the outcome of any internal review, you may complain to the Information Commissioner for a decision on whether your request for information has been dealt with in accordance with the FOI Act.

A request for an internal review should be submitted in writing to FOI Request Reviews, NHS Improvement, Wellington House, 133-155 Waterloo Road, London SE1 8UG or by email to nhsi.foi@nhs.net.
