Your email dated 23<sup>rd</sup> January 2015 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

*I would like to make a request under the Freedom of Information Act to see any outstanding contracts between your department and Babcock including the length and value of each contract.*

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Details of all current contracts between the MOD and the Babcock group are shown in the attached spreadsheet. While some of the contracts have end dates in the past, they are still considered open as they have either had payments registered against them recently or they have been extended, but the MOD contracts database has not yet been updated to reflect this.

For seven contracts the information you have requested falls entirely within the scope of the qualified exemptions provided for at Section 26 (Defence) and has been withheld.

Section 26 is a qualified exemption and is subject to public interest testing which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure. Section 26 (1) (b) has been applied as the information contains sensitive details whose release could allow conclusions to be drawn about the capability of the Armed Forces. The balance of public interest concluded that while release of this information would enhance the accountability of the MOD through information about its contractual processes, there is a strong public interest in not releasing any details that would prejudice the capability of our Armed Forces or give a tactical advantage to our enemies. I have set the level of prejudice against release of the exempted information as 'would be likely to'.

Some of the information you requested was considered to possibly fall within the scope of the qualified exemptions provided for at Section 24(1) (National Security).

Section 24 is a qualified exemption and is subject to public interest testing which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure. Having weighted information, it was considered that there were no grounds for withholding information under Section 24 (1).

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1<sup>st</sup> Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail [CIO-FOI-IR@mod.uk](mailto:CIO-FOI-IR@mod.uk)). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
