<b>Change Title:</b> Addition of Early Years Pupil Premium to codeset		

**Data item / Rule Number:**

To add Early Years Pupil Premium to the Pupil Premium Indicator codeset D00234. This would mean creating a new codeset to include this change.

**Description of change:**

To add new code for 'Early Years Pupil Premium' to the Pupil Premium Indicator codeset.

D00234	Pupil Premium Indicator
DPP	Deprivation Pupil Premium
SCP	Service Child Premium
LAP	Looked After Premium
AFC	Adopted from Care Premium
EYP	Early Years Pupil Premium

Creation of a new associated data item, Pupil Premium Indicator, with a new sequential number and CBDS identifier to supersede existing data item. All other metadata items remain the same as for data item 100540.

This change will not affect any data collections.

**Reason for change (including benefits):**

The change is to allow data to be held within school and LA MIS and potentially be included in pupil premium download for 2016/17 if required.

(However, arrangements for if, and how, this will be downloaded to schools and LAs following the 2016 January census are still to be agreed)

**Impact of not doing the change:**

The download will not be able to be fully imported into a schools system. The data item contains important information and without it the number of queries to the department and to software suppliers will increase.

**ISB view of the proposed change:**

Our assessment of this change is as follows:

The change concerns the addition of a new “Early Years Pupil Premium” value to the Pupil Premium Indicator Code Set. The values will then be:

D00234	Pupil Premium Indicator
DPP	Deprivation Pupil Premium
SCP	Service Child Premium
LAP	Looked After Premium
AFC	Adopted from Care Premium
<b>EYP</b>	<b>Early Years Pupil Premium</b>

Currently the ISB standards do not include an indicator for pupil premium. Considering the values in the list above and the criteria for pupil premium, it seems likely that most if not all of these indicators would be derived from atomic data, and therefore it is unlikely that an ISB data standard would be required. However we will add the RFC to the ISB Incident Log so that, in due course, this area can be analysed fully.

We have no objection to the new value being included in the CBDS code list.
