Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the surrender in part of an environmental permit.

The 2 Sisters Food Group Limited (2SFG) bought the business from Lloyd Mauder, in 2008. The original permit LP3737PN was transferred on 05/08/08 to the new owners and given a new permit number EPR/QP3633GP. The Mauder family retained ownership of the land that the business sits on and Lloyd Mauder Holdings Limited leased this back to 2SFG. Until 19/04/09, 2SFG were entitled to use all of the land within the installation boundary. After this date 2SFG were only entitled to use two pockets of land, the land on which the main poultry and meat cutting/packing buildings stands and the effluent treatment plant (ETP), with a right of access between the two. Although de-commissioning of the operations within the lamb plant and red meat cutting/ packing, further processing and sausage departments was undertaken in 2009 and buildings demolished in 2010, the land has remained within the permitted installation boundary.

This part surrender notice reduces the permitted area.

Any changes made as a result of the part surrender are set out in the schedules.

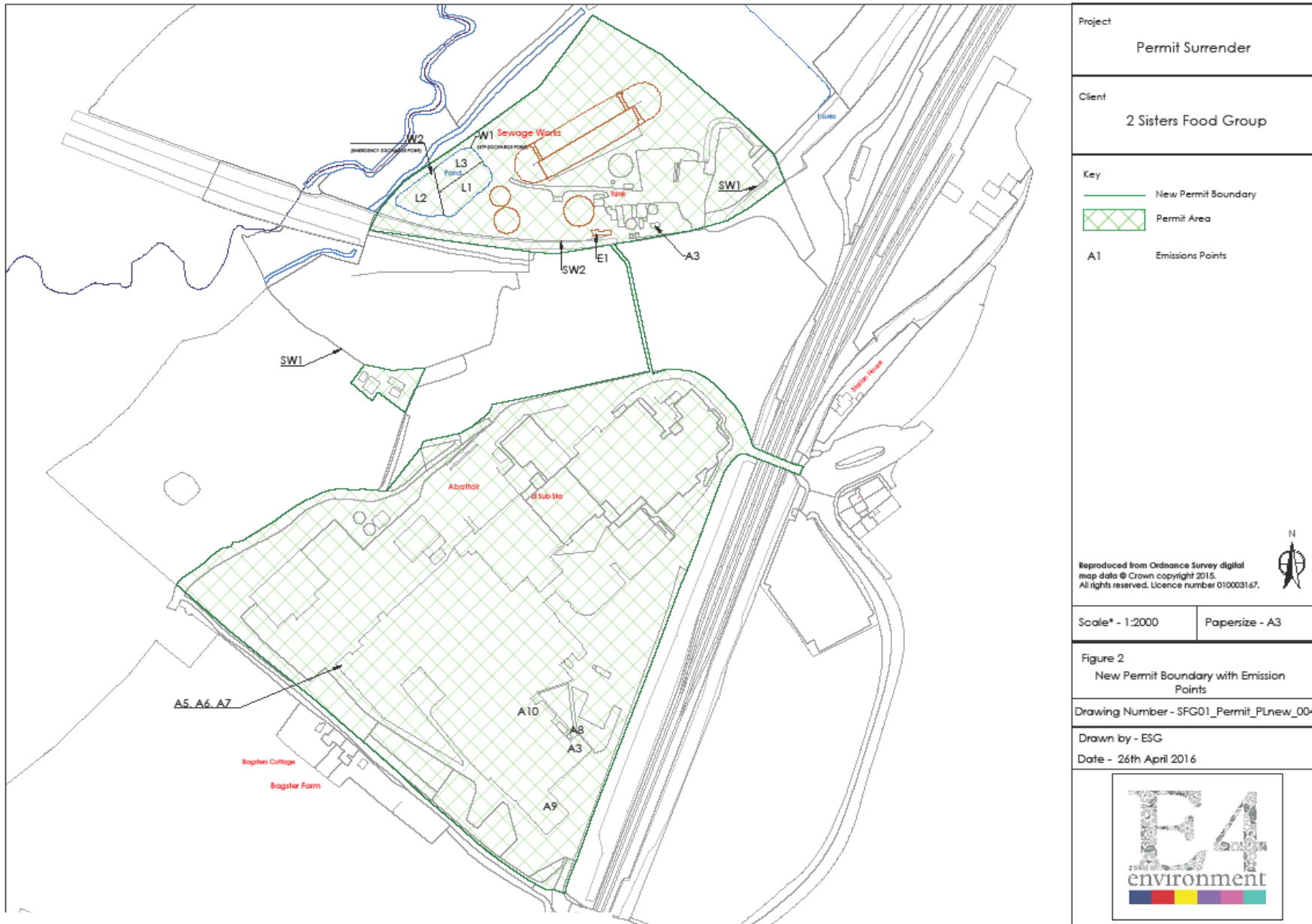
