Discretionary Housing Payments government contribution for 2016/17

Introduction

1. This circular gives details of each local authority's (LAs) government contribution and overall expenditure limit for Discretionary Housing Payments (DHPs) for 2016/17.

Background

- DHP funding was increased from 2011/12 to 2013/14 to assist with the transition of claimants into the new welfare entitlement that resulted from the Housing Benefit (HB) related welfare reforms. In 2014/15 and 2015/16 funding levels reduced in line with the transitionary nature of the additional funding and as claimants adjusted to the reforms.
- 3. To help LAs manage the impact of the HB reforms announced in the Summer Budget 2015, the overall DHP funding will be £150 million for 2016/17, an increase of £25 million (20%) compared to 2015/16 funding. This comprises of funding for four separate areas of support; Core funding, Local Housing Allowance (LHA), Removal of the Spare Room Subsidy (RSRS) and Benefit Cap.
- 4. The distribution of the DHP funding is based on the effect of each element on individual LAs.

Distribution of the government contribution

Core funding (£20 million):

5. We have retained the same methodology for distributing Core funding as in 2015/16, which is to pro-rata the Core allocation based upon the most recent figures available in respect of the level of expenditure for HB in 2013/14. This is based on the <u>DHP Order 2001 Article 2 (a)</u>.

Local Housing Allowance (£30 million)

6. We have allocated £25 million using the same methodology as 2015/16 where distribution is based on aggregate losses from the package of LHA reforms and £5 million has been allocated according to the proportion of claimants in the private rented sector in each LA.

Removal of the Spare Room Subsidy (£60 million)

7. The allocation of RSRS DHP funding in 2016/17 will be the same as in previous years. The distribution of £55 million of the funding will be based on the aggregate RSRS losses in each LA area, calculated from the latest statistics

available from <u>Stat-Xplore</u> on numbers of claimants with a deduction and the average weekly deduction. £5 million of the funding will continue to be distributed to the 21 most sparsely populated LAs, using the same methodology based on aggregate RSRS losses.

Benefit Cap (£40 million):

8. We have split the £40 million into two different pots to take into account both the current Benefit Cap and the lower Benefit Cap, which is due to come into effect in 2016/17 with the split 45% and 55% respectively. For the 45%, the allocation will be the same methodology as 2015/16 which is based on the proportion of all capped funds (savings from the cap) from households capped by more than £50 per week in each LA. The 55% would be allocated according to LAs' proportion of total AME reduction for the new cap.
