

# **NOTICE OF ORDER**

## **WILDLIFE AND COUNTRYSIDE ACT 1981**

### **SECTION 53**

Royal Borough Of Windsor & Maidenhead  
The Footpath 16 Windsor Modification Order 2014 Definitive Map and  
Statement

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. Following an earlier inquiry, the Inspector appointed to determine the Order issued a letter in which she proposed to make modifications to the Order as drafted. Following advertisement of those proposals objections/representations have been received.

The **start date** for the above Order is **02 February 2016..**

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case which contain evidence in respect of the Inspector's proposed modifications only.

The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by adding to them a footpath which commences at point A between properties 36 and 38 Priors Road (grid reference 493957-176-29) running generally easterly for 44m to point B (grid reference 494000-176021), then running generally southerly for 5 metres to Point C (grid reference 493999-176016), then running generally easterly for 32m to point D (grid reference 494031-176013), then running in a curving but generally north easterly direction to point E between properties 30 and 32 Keepers Farm Close (grid reference 494044-176037). Width: A-B-C: varying between 1.5m and 1.7. C-D-E: 1.5m.

The effect of the proposed modifications would be to modify the Order by providing for the following modifications:

- In Parts I and II of the Schedule to the Order, where the width of the path is described, delete the existing descriptions and substitute with the following in each case:
  - A-B 1.8 metres
  - B-C 2.4 metres
  - C-D-E 4 metres
- On the Order plan, delete all references to the width of the path shown in rectangular boxes and with arrows at seven locations, and re-align the path as indicated by a dashed red line

### **Timetable for sending in statements of case and comments**

#### **Within 8 weeks of the start date [by 29 March 2016]**

The Order Making Authority, the applicant and everyone who has made an objection or representation following the proposed modification(s) or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after receiving it the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation following the proposed modification(s), the applicant and any other person who has previously written to us in respect of the Order.

#### **Within 14 weeks of the start date [by 10 May 2016]**

Everyone who has made an objection or representation following the proposed modification(s), the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the above date, the Secretary of State will send copies of the comments received to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
