

**NOTICE OF ORDER**

**HIGHWAYS ACT 1980 SECTION 119**

**RE-ARRANGED INQUIRY**

Telford & Wrekin Borough Council  
Public Path Diversion Order Borough of Telford and Wrekin Parish of  
Ketley (Bali-Hi Footpath No. 191 and 193)

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The original **start date** for this Order remains unchanged (**11 August 2015**).

Consideration of the Order will take the form of a public local inquiry.

The re-arranged Inquiry will now be held at **Meeting Point House, Southwater Square, Telford, Shropshire, TF3 4HS** on **Tuesday 12 July 2016** at **10.00am**.

The effect of the Order, if confirmed without modifications, will be to divert the public footpaths 191 and 193 which commence as footpath 191 from its junction with Shrubbery Road adjacent to the property known as Bali-Hi in a north easterly direction for approximately 90 metres to a junction with public footpath 193 and then continues in a north easterly direction for approximately 85 metres to a gate and junction with footpaths 197 and 194 and restricted byway 196, to a line running in a generally north direction from its junction with Shrubbery Road and between numbers 37 and 44 the route being a stone surfaced track having an approximate width of 3 metres continues in a general northerly direction for a distance of 64 metres to a wooden kissing gate then continues in a general north-north-easterly direction as a 1.2 metre wide tarmac path for a further 80 metres to the wooden kissing gate at the junction with Quarry Lane opposite the property called Willow Dene.
