We have considered your request in accordance with the Environmental Information Regulations 2004 (EIRs) because the information you seek falls within the definition of "environmental information" as stated in the EIRs.

Following a search of our paper and electronic records, I have established that the Department holds information falling within the terms of your request under point one. The Department does not hold any information relating to point two of your request other than already included in the information under point one. Copies of the information are attached in **Annex A**.

After careful examination, DECC considers that some of the information is exempt from disclosure under Regulation 13(1), relating to the disclosure of personal data. Regulation 13(1) of the EIRs is an absolute exception and is not subject to a public interest test.

## Regulation 13(1) of the EIRs

Some of the information constitutes personal data and has been withheld. Regulation 13(1) of the EIRs provides an absolute exception from disclosure for personal data, which then falls to be dealt with under the Data Protection Act (DPA).

Personal data of third parties can only be disclosed under the data protection principles. In particular, the first data protection principle requires that disclosure must be fair and lawful and must comply with one of the conditions in Schedule 2 of the DPA. We do not think it is fair to release the names and contact details of DECC staff below Senior Civil Service level, or staff in other organisations, and do not think that any of the relevant conditions in Schedule 2 of the DPA apply.

## **Appeals Procedure**

If you are dissatisfied with the result of your request for information, you may request an internal review within 40 working days of the date of receipt of the response to your original letter. If you wish to request an internal review, please contact:
