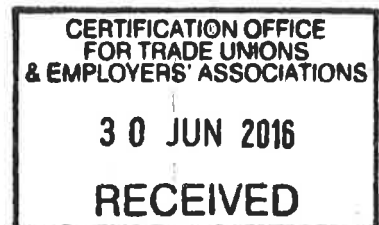




Income and Expenditure

The total income of the union for the period was £4002. This amount included payments of £4002 in respect of membership of the union. The union's total expenditure for the period was £4376.

Irregularity statement

"A member who is concerned that some irregularity may be occurring, or have occurred, in the conduct of the financial affairs of the union may take steps with a view to investigating further, obtaining clarification and, if necessary, securing regularisation of that conduct.
