FREEDOM OF INFORMATION ACT 2000 REQUEST REF: FOI Request Ref 0081-15

Thank you for your email of 21st January 2015 asking for information under the Freedom of Information Act (FOIA) 2000. You asked:

1. *How many penalty charge notices were paid for by your department in 2010/11, 2011/12, 2012/13, 2013/14 and 2014/15 so far?*
2. *What were the total cash values of these penalty charge notices in each of these years?*
3. *What was the most expensive individual penalty charge notice?*
4. *How many of these penalty charge notices were paid for on behalf of or claimed by civil servants?*
5. *How many of these penalty charge notices were paid for on behalf of or claimed by visitors?*
6. *How many of these penalty charge notices were paid for on behalf of or claimed by Ministers or their office of staff?*
7. *If on behalf of a Minister or their office of staff please can I have the name of that Minister, a distinction between his/her office staff and themselves, a breakdown by year and the total cash values by year?*

The London Car Service is provided by FCO Services, an Executive Agency and Trading Fund of the Foreign and Commonwealth Office (FCO). As such, this request has been passed to our offices for the provision of information that we may hold in relation to your FOI Request to the FCO.



I can confirm that we have now completed a search for the information which you requested, and that FCO Services does hold some information relevant to your request.

The details requested are as follows:

Records of PCN's have been held and recorded by FCO Services since the year 2013/2014. In this period two notices were paid for by FCO Services.

Breakdown of the two PCN's paid

1. There have been two PCN's in 2014/2015 so far.
2. Both PCN's were £65.00. Therefore the total amount paid was £130.00.
3. The most expensive individual PCN was £65.00.
4. Both were paid for on behalf of civil servants by FCO Services.
